Respected Sir,

In producing herewith arrested accused person namely Hamsaraj Majhi (24), S/o- Lt. Paban Majhi of village-Bankudih ,PS-Balarampur, Dist- Purulia along with one seized Blue & Black coloured Splendor iSmart Motorcycle bearing Registration No- JH05 BV 3548.

I beg to report that today myself along with C/922 Sanjoy Bauri, C/346 Saktipada Rajak both of Kenda PS were performing Spl. mobile duty at Darodih More under Kenda PS area vide Kenda PS C.C No-975/22 dtd. 10.10.2022 and Kenda PS GDE No- 277 dtd- 10.10.2022 at about 11:05 hrs, I found one Motorcycle bearing Registration No- JH05 BV 3548 coming from Taltal Hat side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place rashly, so there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger for human life.

So, I arrested him as he violated Sec. 279 IPC and also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore, I pray that a specific case may kindly be start against accused Hamsaraj Majhi (24), S/o- Lt. Paban Majhi of village-Bankudih ,PS-Balarampur, Dist- Purulia
