I, SI Joydev Mahato of Kenda PS, Dist-Purulia producing herewith one arrested accused person namely Parikshit Majhi (50 yrs), S/o – Lt Khandu Majhi of Vill-Penchara Majhi Para, P.S – Kenda, Dist-Purulia with seized articles i.e. 1) one white colour jarican containing approx 15 Ltrs. ID Liquor 2) 10 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from Sl. No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (11-10-2022) during day Mobile duty acting of a secret source information myself along with, C/ 2519 Arun Duley, C- 2644 Mithun Duley both of Kenda PS conducted raid in the house of Parikshit Majhi at village Penchara at about 14:55 hrs and found that he was keeping and selling of ID liquor at his house to the others. Seeing the Police party, all customers fled way but we managed to apprehend the above noted accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing approx 15 Ltrs. ID Liquor 2) 10 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from \$1 No-01 & kept in a bottle which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities.
