Sub: Prayer for starting a specific case against one Babar Sekh (29 Yrs) S/o Hanif Sekh of Vill Purano Jhalda, PS-Jhalda, Dist-Purulia, the rider of TVS Apache RTR- 160 Motor Cycle having Regd. No-JH 01CL 1036

Respected Sir,

With due respect I ASI Sanjoy Dey beg submit before you that on 18.10.2022 at about 15:25 hrs while myself along with C/1524 Krishna Ch. Mahato, C/1543 Prabir Mandal were performing Day mobile duty (MV Checking) vide Kotshila PS CC No- 2155/22 Dated-18.10.2022 at Jabragora More on Purulia Ranchi Road (SH-4A). I found one Motor Cycle having Regd. No- JH 01CL 1036 was coming from Jhalda side towards Joypur side with Driving Dangerously. Police personnel of MV Checking party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him at Jabragora More. On interrogation he made incoherent statement at different time. He disclosed his identity as Babar Sekh (29 Yrs) S/o Hanif Sekh of Vill Purano Jhalda, PS-Jhalda, Dist-Purulia driver of Motor Cycle having Regd. No- JH 01CL 1036. On being asked he failed to produce the driving license and other valid documents of Motor Cycle having Regd. No- JH 01CL 1036.

Hence he violated the provision of Section 279 IPC & R/W Section-184/181 MV Act. So I seized the Passion Pro Motor Cycle having Regd. No- JH 01CL 1036 at 15:35 hrs to 15:45 hrs under proper seizure list duly signed by the witnesses and arrested the offending driver namely Babar Sekh (29 Yrs) S/o Hanif Sekh of Vill Purano Jhalda, PS-Jhalda, Dist-Purulia at 15:55 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest.

So I pray a specific case may kindly be registered against the accused namely Babar Sekh (29 Yrs) S/o Hanif Sekh of Vill Purano Jhalda, PS-Jhalda, Dist-Purulia driver of Passion TVS Apache RTR- 160 Motor Cycle having Regd. No-JH 01CL 1036 for committing offence U/S 279 IPC & R/W Section-184/181 MV. Act.
