Respected Sir,

In producing herewith one arrested accd. Pratham Mahato (26 yrs), S/O Shiblal Mahato of Vill- Durgu, PS- Kotshila, Dist-Purulia with seizure of approx 10 (Ten) liters illicit liquor (Cholai) from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (29.10.2022) during evening mobile duty on acting secret source information I held raid 17:05 hrs in the house of above noted person at Durgu village who was stocked illicit spirit in his house. I searched the place and found approx 10 (Ten) Liters illicit spirit which was kept in a white colour Jaricane. On interrogation he disclosed his name and address as noted above and also stated that he uses to sell the same for his gain in liu of money. On demand he failed to produce any valid documents in respect of illicit spirit which was kept in his house. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith in between 17:15 hrs to 17:35 hrs. As such he was arrested at 17:45 hrs U/S- 67 B.E. Act and during arrest the ground of arrest was duly notified issuing arrest memo U/S- 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 500 (Five Hundred) ml. was taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Pratham Mahato (26 yrs), S/O Shiblal Mahato of Vill-Durgu, PS- Kotshila, Dist-Purulia violated the provision of section 18 (i) B.E. Act. for possessing and selling of illicit spirit without obtaining license from a licensing vendor and in contravention, he Committed an offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid C/292 Krittibas Mahato & C/557 Ambuj Mandal accompanied me Vide Kotshila P.S C.C No 2256/2022, Dated 29.10.2022.

Under the fact and circumstance I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against arrested accd person namely Pratham Mahato (26 yrs), S/O Shiblal Mahato of Vill-Durgu, PS- Kotshila, Dist-Purulia.
