Sir,

In producing here with 01(One) arrested accused person named Rampada Mahji (28) S/O Lt-Chinu Majhi of village-Pirargoria, PS-Manbazar, Dist-Purulia along with seized motor cycle (Red Colour, Super Splendor) without Registration, Bearing chassis no- MBLJAW17XM9L04048. Engine no- JA07ABM9L10175.

I beg to state that today i.e on 07.10.2022 in course of my evening mobile duty vide Manbazar PS GDE No.224 dt.07.10.2022 I had been at Challa more side under Manbazar PS at 18:45 hrs and found that the driver of the above mentioned motor cycle was coming from Challa Hat side on Manbazar-Lalpur road with excessive speed and rough driving in negligence manner without wearing helmet. I along with force signalled to stop him but the driver of the said motor cycle drove speedily and disobediently and tried to flee away. Somehow we could be able to detain him near Samsan Kali Mandir on Manbazar-Purulia road under Manbazar PS. This rough and negligence driving of the driver would lead to an accident at any time and any passerby could be injured by such activities. On being asked the above accd. person could not be able to give any satisfactory answer for his movement on road and public place by such rough driving and also could not able to produce any valid documents in respect of said motor cycle as well as DL. So I seized the motor cycle (Red Colour, Super Splendor) Bearing chassis no- MBLJAW17XM9L04048. Engine no-JA07ABM9L10175 at 19:05 hrs after preparing proper seizure list duly signed by the witnesses and arrested the driver of above mentioned motor cycle at 19:35 hrs for rough and negligent driving after maintaining all arrest norms.

So, a specific case may kindly be started against Rampada Mahji (28) S/O Lt- Chinu Majhi of village-Pirargoria, PS-Manbazar, Dist-Purulia as per law and arrange for its investigation.
