In producing here with 01(One) arrested accused person named Rampada Mahji (28) S/O Lt-Chinu Majhi of village-Pirargoria, PS-Manbazar, Dist-Purulia along with seized motor cycle (Red Colour, Super Splendor) without Registration, Bearing chassis no- MBLJAW17XM9L04048. Engine no- JA07ABM9L10175.

I beg to state that today i.e on 07.10.2022 in course of my evening mobile duty vide Manbazar PS GDE No.224 dt.07.10.2022 I had been at Challa more side under Manbazar PS at 18:45 hrs and found that the driver of the above mentioned motor cycle was coming from Challa Hat side on Manbazar-Lalpur road with excessive speed and rough driving in negligence manner without wearing helmet. So, a specific case may kindly be started against Rampada Mahji (28) S/O Lt- Chinu Majhi of village-Pirargoria, PS-Manbazar, Dist-Purulia as per law and arrange for its investigation.
