I beg to state that today i.e on 30.10.2022 in course of my day mobile duty vide Manbazar PS GDE No.1076 dt.10.10.2022 I had been to Challa more side at 15:05 hrs and found that the above noted person with his Motorcycle Bearing Reg. No. WB56D/2161 was coming from Puncha side with excessive speed and rough driving in negligence manner without wearing protective head gear. Myself along with force signalled to stop him but the driver of the said motorcycle drove speedily and disobediently and tried to flee away. Somehow we could be able to detain him near Challa more on Manbazar-Purulia road under Manbazar PS. This rough and negligence driving of driver would lead to an accident at any time.
