Respected Sir,

With due respect I, SI Shib Narayan Singh, beg to submit before you that on 10/10/2022 at about 09:05 hrs while myself along with force C/1302 Radhagobinda Dhibar and NVF/711 Sunil Singh were performing day mobile duty vide Neturia PS GD No-385 Dated-10/10/2022 at Parbelia Bazar on Purulia-Barakar Road. I found one vehicle was coming from Barakar side towards Raghunathpur side with driving in excessive speed. Police personnel, present there in proper Police uniform raised hand and directed him to stop the vehicle but he violated the Police Signal and endangering human life by rash and negligently driving of the vehicle which may cause accident to the road user any time. After long chase we can able to apprehend him near Sonu Hotel, PS-Neturia. On interrogation he disclosed his identity as Bimalesh Kumar (20 Years) S/O- Bimal Yadav of Vill-Kothiya, PO-Pinjrawan, PS-Kinjar, Dist-Arwal, Bihar. On being asked he failed to produce any valid documents of the said vehicle. Hence, he violated the provision of Section 279 IPC/184 MV Act. So, I seized the vehicle having Regd. No- NL 01AE/5363 under proper seizure list duly signed by the witnesses and arrested the above noted offending driver avoiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court.

So, I pray before you that a specific case may kindly be registered against the accused driver Bimalesh Kumar (20 Years) S/O- Bimal Yadav of Vill-Kothiya, PO-Pinjrawan, PS-Kinjar, Dist-Arwal, Bihar (Driver of vehicle having Regd. No- NL 01AE/5363) committing offence U/S-279 IPC/184 MV Act.
