I, SI Kousik Banerjee, O/C Neturia Ps, Dist-Purulia do hereby lodge complaint suo-moto against (1) Tannu Tiwari (31 Years) W/O- Vishal Kumar Tiwari of Simultola I No. Mahisila Colony, PS-Asansol (South), Dist-Paschim Burdwan (2) Vishal Kumar Tiwari (35 Years) S/O- Lt. Balmiki Tiwari of Do (3) Ankesh Ranjan Pal (48 Years) S/O- Anil Krishna Pal of Do (4) Pannalal Dutta (52 Years) S/O- Lt. Anil Chandra Dutta of Do (5) Anjana Pal (45 Years) W/O- Ankesh Ranjan Pal of Do (6) Antika Pal (19 Years) D/O-Ankesh Ranjan Pal of Do to the effect that today i.e. 01.10.2022 at about 00:45 hrs I had been at PS and found the vehicle movement on Purulia – Barakar pitch road (SH-5) almost became stagnant. Accordingly I went out from the PS being accompanied with C/939 Laltu Paul CVF Sunil Kumar Paswan to verify the reason of such disruption of free flow of traffic through the road. On enquiry I found a vehicle having registration No- WB 38AW/5656 (Mahindra Thar) was parked on the road and caused obstruction to the free flow of traffic. I made out a search to trace out the driver / owner of the said vehicle with a view to remove the said vehicle so that the normal flow of traffic can be restored. In the mean time one person came there and opened the door of the driver side of the vehicle and started the vehicle sitting on the driver seat. The said person was yet to move the said vehicle then all a sudden 04/05 persons including 03 (Three) female came there and started argument and also asked me who are you to direct us to move the vehicle. Then I after disclosing my identity to them, request them to leave the place with their vehicle without any argument. But they started abusing me and my accompanying force by using filthy languages and started assaulting us with fist and blows. However we could manage to brought them at PS with the help of Neturia Durga Puja Committee members namely (1) Aparesh Upadhyay (22 Years) S/O- Baban Upadhyay (2) Abhijit Pandey (21 Years) S/O- Nabani Pandey and (3) Raj Sukul (25 Years) S/O- Santa Sukul all are of Vill+PO+PS-Neturia, Dist-Purulia who were also present on spot. After entering the PS compound they again started assaulting us in presence of those Durga Puja committee members. Being heard the sound of quarrel other officer and force came there including 03 (Three) lady constable namely (1) LC/3071 Nupur Rajak (2) LC/779 Sathi Majee and (3) LC/338 Rinku Mudi and C/174 Prasad Majhi who was performing PS sentry duty. Suddenly the women members of the said team under the leadership of Tannu Tiwari started to assault the lady constable by fist and blows and also kick off on different part of the body of one of our lady constable namely Nupur Rajak and Tannu Tiwari also throttled her neck in such a way, there was every chance of her death due to the suffocation. However other lady constables could manage to rescue the said lady constable (Nupur Rajak) from her hands. Due to such assault, the said lady constable received injury on her neck and other part of the body. They also assaulted me, C/174 Prasad Majhi and CVF Sunil Kumar Paswan. The said lady (Tannu Tiwari) also damaged the door of the PS Child friendly corner. At last with the help of other forces & lady constables, we could manage to apprehend them & kept them at PS office & the involved vehicle having registration No- WB 38AW/5656 also brought to PS. Under the above facts & circumstance the said persons thereby deter a public servant to discharge his lawful duty and also assaulted me and other police personnel and caused serious injuries in their persons and also attempted to murder of a lady constable as well as caused damage of Government property in furtherance of their common intention and also obstructed the Purulia – Barakar road (SH-5). On interrogation they disclosed their identity as (1) Tannu Tiwari (31 Years) W/O- Vishal Kumar Tiwari of Simultola I No. Mahisila Colony, PS-Asansol (South), Dist-Paschim Burdwan (2) Vishal Kumar Tiwari (35 Years) S/O- Lt. Balmiki Tiwari of Do (3) Ankesh Ranjan Pal (48 Years) S/O- Anil Krishna Pal of Do (4) Pannalal Dutta (52 Years) S/O- Lt. Anil Chandra Dutta of Do (5) Anjana Pal (45 Years) W/O- Ankesh Ranjan Pal of Do (6) Antika Pal (19 Years) D/O-Ankesh Ranjan Pal of Do and on demand they also failed to produce any age proof certificate in respect of the girl namely Antika Pal, aged approx 19 Years to verify her actual age at this moment. Later myself along with the force who sustains injury in their persons had been to Harmaddih CHC and got medically treated. The above noted persons committed offence U/S- 341/186/353/332/333/337/338/307/34/283 IPC & read with Sec. 18 of the West Bengal Highway Act 1964 & 3 PDPP Act. Hence, after returning from Harmaddih CHC, I do hereby lodge this complaint against above noted accused persons to start a specific case U/S- 341/186/353/332/333/337/338/307/34/283 IPC & read with Sec. 18 of the West Bengal Highway Act 1964 & 3 PDPP Act.
