Sir,

In producing here with one arrested accused person namely Bisu Roy (52 yrs) S/O Lt. Shraban Roy of Vill- Shibdih, PS- Purulia (M), Dist-Purulia along with seized article i.e. One white colour plastic container containing approx 10 ltrs. of ID liquor and (Approx 500 ml taken out from of the above container as sample packed with sealing wax).

I, ASI Ajoy Mukhapadhyay do hereby lodge a written complaint against the above noted accused person to the effect that today i.e 03.10.2022 at about 17:05 hrs. during my Ranchi Road evening duty under Purulia (M) PS area, receive source information over telephone that the above noted accused has been selling ID liquor in his shop at Shibdih village. On receiving the source information I communicated with I/C Purulia (M) PS over telephone and as per direction I along with (i) C/297 Apurba Pandey, (ii) C/2078 Haripada Das & (iii) HG/1576 Shaktipada Mahato all of Purulia (M) PS rushed to the shop of above noted suspected person to work out the information vide Purulia (M) PS C.C. No. 3611/2022 dtd. 30.10.2022. Reaching at Shibdih village at about 17:55 hrs we fixed-up in the shop of Bisu Roy S/O Lt. Shraban Roy of Vill- Shibdih, PS- Purulia (M), Dist-Purulia and found that One white colour plastic container containing approx 10 ltrs. of ID liquor as sell proceed. There was one person inside that shop who, seeing the police party, had made a deliberate attempt to flee-away, but we were able to apprehended the above noted accused person who was selling I.D Liquor which he use to sell claudestinely to make his profit. On demand he failed to produce any valid documents in support of selling I.D Liquor. Accordingly, I seized the articles after preparing a proper seizure list and put label on the seized article from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses and approx 500 ml taken from the white colour plastic container as sample packed with sealing wax with label. It took time from 18:05 hrs. to 18:10 hrs. During interrogation he confessed his guilt. Therefore, I arrested him at 18:15 hrs after observing all the formalities issuing memo of arrest.

Under the above circumstances I, therefore, pray that a specific case u/s 46 (A)(c) of The Bengal Excise Act may kindly be registered against said Bisu Roy (52 yrs) S/O Lt. Shraban Roy of Vill-Shibdih, PS-Purulia (M), Dist-Purulia and also for arranging its investigation.
