Sub: Prayer for lodge F.I.R.

Sir,

In producing herewith the one arrested accused person namely Safaul Ansary (45Y) S/O-Lt. Jamuruddin Ansary of Vill-Hatimara, P.S.-Para, Dist-Purulia.

I do here by lodging written complain that today i.e. on 16.10.22 at about 11:05 hrs. O/C of Para P.S. received an information from V.P. Shidhartha Sankar Mudi who is the village Police of Nadiha Surulia G.P. that one Safaul Ansary S/O-Lt. Jamuruddin Ansary of Vill-Hatimara, P.S.-Para, Dist-Purulia has arranged a Buffalo fight which is locally known as "KARA LARAI" with his other associates at Hatimara Puratan field near Hatimara village which is one of the remotest area of this P.S. Receiving this information, myself along with force left for P.O. as per instruction of O/C Para P.S. to stop said Buffalo fight. This refers to Para P.S. GDE No. 620, Dtd-16/10/22.

Then, myself along with force reached at the spot at about 11:45 hrs. and contacted with V.P. Shidhartha Sankar Mudi who informed me that few minutes earlier Buffalo fight was started in between two Buffaloes and those two suddenly started run towards the mob who were came to watch Buffalo fight. Accordingly, all spectators suddenly started to run aimlessly to save themselves. During this, one Rathu Bauri (57Y) S/O-Lt. Fatik Bauri of Vill-Nadiha, PS-Para, Dist-Purulia fall down and run over by the people who were gathered there to watch the Buffalo fight. As a result, he received serious injury in his person and shifted to Kustaur B.P.H.C by local people on emergency basis. People from different places were gathered here with their Buffalos to take part in the event. I found that the Buffalo fight had already been discontinued after the said incident. I also visited the place both where the Buffaloes were fighting and the person became injured. In-course of enquiry, I came to know that the injured person namely Rathu Bauri (57Y) S/O-Lt. Fatik Bauri of Vill-Nadiha, PS-Para, Dist-Purulia has been brought dead at Purulia Sadar Hospital as he was referred from Kustaur B.P.H.C. Primary enquiry revealed that the event was organized by said Safaul Ansary S/O-Lt. Jamuruddin Ansary of Vill-Hatimara, P.S.-Para, Dist-Purulia and his other associates without any permission in an unlawful manner and in a negligent manner without taking any safety precautions from the point of view of human life threat knowing that Buffalo is a ferocious animals and it is always danger to human life if not guarded properly. Their Act caused the death of one person. Though, they had the knowledge that it is likely to cause death to anyone if the event is not avoided. The entire animals were kept under the possession of the organizer and owners jointly. Whoever, keeps an animal accustomed to attacking humans. It is his / their responsibility to reduce the mischievous propensity. Always, Buffaloes are the probable danger to human life. Hence, any negligent act is not permissible.

The organizers & owners are also violating the law as per prevention of cruelty to animals act as the Buffaloes being tortured and get unnecessary pain for this Buffaloes fighting.

Accordingly, I held raid and arrested the principal organizer namely Safaul Ansary (45Y) S/O-Lt. Jamuruddin Ansary of Vill-Hatimara, P.S.-Para, Dist-Purulia from the spot i.e. Hatimara Puratan field near Hatimara village after prepared proper arrest memo and interrogate him properly. During interrogation, he disclosed the name of co-organizers who are (1) Tapan Mahato S/O-Lt. Haralal Mahato (2) Alauddin Ansary S/O-Kurban Ansary (3) Bhadari Mahato S/O-Lt. Pahalal Mahato (4) Arun Mahato S/O-Jaleswar Mahato (5) Gurupada Mahato S/O-Lt. Chandra Mohan Mahato (6) Nirodh Mahato S/O-Lt. Kalipada Mahato (7) Rabi Rajwar (8) Sushil Mahato all are of Vill-Hatimara, PS-Para, Dist-Purulia and others. He further disclose that Buffalo of one Krishnapada Mahato S/O-Haresh Mahato of Vill-Golamara, PS-Purulia (M), Dist-Purulia and Buffalo of one Shaktipada Roy of Vill-Lakhipur, PS-Chandankeyari, Dist-Bokaro, Jharkhand was fighting while the incident took place. Beside this, the below mentioned persons were remain present at the spot with their respective Buffalos to participate in the event (1) Raban Mahato of Vill-Golamara, PS-Purulia (M), Dist-Purulia (2) Bhalu Gorai of Vill-Jalka, PS-Purulia (M), Dist-Purulia (3) Baidyanath Mahto of Vill- Hatimara, PS- Para, Dist- Purulia and others.

I further requested the arrested person to produce any valid papers in support of the event. But, he failed to produce the same. The event was organized with knowledge that it is likely to cause death or bodily injury in case of any negligence.

Hence, I pray before your kind honour that a specific case may kindly be start under proper section of law.
