Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Manbodh Dutta (55 yrs), S/O- Lt. Baul Dutta of vill+PO+PS-Puncha District- Purulia A/P- Vill-Barameshya, PS- Puncha, Dist- Purulia with seized articles i.e. (1) One white plastic container containing 19 Ltrs ID liquor (2) One motor cycle (Hero Super splendor) bearing Reg. No-WB56Q/8369 loaded with SL No-1 (3) One Ltrs of ID liquor collected in a plastic bottle from SL No-1 as a sample, which were seized and labeled under proper seizure list.

I beg to submit that today (19.10.22) at 17.05 hrs while myself along with C/1260 Sontosh Soren and C/617 Mirtunjoy Sahana vide Puncha PS CC No-2250/22 Dated 19.10.22 were performing Spl. pre Diwali drive duty at Puncha side. During Spl. pre Diwali drive duty received source information that one Manbodh Dutta (55 yrs), S/O- Lt. Baul Dutta of vill+PO+PS-Puncha District- Purulia A/P- Vill-Barameshya, PS- Puncha, Dist- Purulia has illegally stocked liquor in his motor cycle & selling the same near Dalaha more, PS- Puncha, Dist- Purulia. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Dalaha more side to work out the information after reaching at near Dalaha more and held raid and search against Manbodh Dutta (55 yrs), S/O- Lt. Baul Dutta of vill+PO+PS-Puncha District- Purulia A/P- Vill-Barameshya, PS- Puncha, Dist- Purulia and found that the above noted person was keeping / selling liquor which were kept in a white plastic container in his motor cycle (Hero Super splendor) bearing Reg. No-WB56Q/8369, on demand Manbodh Dutta failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. Accordingly I seized (1) One white plastic container containing 19 Ltrs ID liquor (2) One motor cycle (Hero Super splendor) bearing Reg. No-WB56Q/8369 loaded with SL No-1 (3) One Ltrs of ID liquor collected in a plastic bottle from SL No-1 as a sample under proper seizure list duly signed by witnesses and labeled, out of which 01 Ltr. collected in plastic bottle as a sample at the time of seizure the same and labeled under proper seizure list duly signed by witnesses as well as one of the same bottle is taken as a sample which is sealed and labeled. After seizure I arrested the accd Manbodh Dutta (55 yrs), S/O- Lt. Baul Dutta of vill+PO+PS-Puncha District- Purulia A/P- Vill-Barameshya, PS- Puncha, Dist- Purulia as he committed offence u/s 46 A(c) B.E. Act 1909. During arrest the ground of arrest was duly notified, issued arrest memo and handed a copy of the same to arrestee. I also issued check list U/S-41 (1)(a), (b) (I), (II) Cr.P.C. Direction of the Supreme Court of India vide Criminal Appeal No.-1277 of 2014, Spl. Leave petition.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against the arrested Manbodh Dutta (55 yrs), S/O- Lt. Baul Dutta of vill+PO+PS-Puncha District- Purulia A/P- Vill-Barameshya, PS- Puncha, Dist- Purulia under proper section of law.
