Sub: Prayer for starting a specific case against one Banku Bauri (27yrs), S/O- Gangadhar Bauri of vill-Saharjuri, PO-K P Rangadih PS-Hura, Dist-Purulia (Rider of black and red colored Bajaj CT 110 Motor Cycle having Reg.No.-WB56T-0854).

Respected Sir,

With due respect I Sujoy Kundu, beg to submit before you that on 21/10/2022 at about 11.45 hrs while myself along with C/1228 Babulal Hansada & NVF/1043 Sazad Ansary were performing naka checking near Napara more on Manbazar-Lalpur pitch Road under Puncha PS vide Puncha PS CC No-2262 Dated-21/10/2022. During Naka checking I found one Motor Cycle having a rider was coming from Lalpur side towards Manbazar dangerously with excessive speed without wearing Helmet. We raised hand and directed him to stop the Motor Cycle but the said Motor Cycle rider, violating the Police Signal and endangering human life by rash and negligently driving the Motor Cycle which may cause accident to the road user any time. Somehow we were able to apprehend him. On interrogation they disclosed their identities as Banku Bauri (27yrs), S/O- Gangadhar Bauri of vill-Saharjuri, PO-K P Rangadih PS-Hura, Dist-Purulia Rider of black and red colored Bajaj CT 110 Motor Cycle having Reg.No.-WB56T-0854). Hence on being asked Banku Bauri, driver of the said motorcycle unable to produce his driving license and RC book of the said motorcycle. So he committed offence U/S 279 IPC read with section 181/184/190(2)/194D MV Act 1988 read with MV (Amendment) Act, 2019.

So I seized the said Bajaj CT 110 Motor Cycle having Reg.No.-WB56T-0854 from the possession of above noted rider of the said motor cycle namely Banku Bauri under proper seizure list duly singed by him and other available witnesses and arrested the offending driver namely Banku Bauri (27yrs), S/O- Gangadhar Bauri of vill-Saharjuri, PO-K P Rangadih PS-Hura, Dist-Purulia abiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bailable I offered him bail but none were turn up before me. On being asked he refused to undergo to medical check up. So finding no other any alternative way I brought him into PS along with seized articles.

So, I pray before you that a specific case may kindly be registered against the accused namely Banku Bauri (27yrs), S/O- Gangadhar Bauri of vill-Saharjuri, PO-K P Rangadih PS-Hura, Dist-Purulia (Rider of black and red colored Bajaj CT 110 Motor Cycle having Reg.No.-WB56T-0854). under proper section of law.
