About 5:00 p.m. Date 06/10/2022 at evening Ganesh dey, Dinesh dey, Uma dey and entire their whole family forcefully entered into our home with intention of killing us,

Ganesh came into my home and starting to beating me and my brother lakhikant with the help of his brother Dinesh dey and all other member of his family.there after Rakhi dey suddenly throw a big stone or brick on my chest to kill me,after that I was badly injured,

I wascaught by the Rakhi dey wife of Dinesh dey,sosti deywife of Ganesh dey,Uma dey mother of Ganesh dey ,Anita dey sister of Ganesh dey, all family of Ganesh dey,

Ganesh dey struck my head by a wooden pole after that I was unconscious due to this attack

At this moment only one family member of my family was present that was my brother lakhikant,he was unable to save me because at this moment Dinesh dey was starting to beating him with other weapons,

My sister jayanti dey and my mother Rekha dey call neighbors to rescue,then shambhu Dey and other people snatch Ganesh and Dinesh dey s'weapon.

But during this time Ganesh dey and Dinesh dey continuously attacking us with wooden pole

I was worsely injured we escape from there to hospital immediately.

Now I am suffering a lot of pain in my head and chest I cannot properly see and I breathe very painful

Sir we have filed many land related case against him in court for their illegal activities ,this is the main reason behind enmity.

now the entire family escape away from here and went to dhanbad near bank more of there rental house,but their permanent address is Dimdiha,purulia, (wb)

At last I requesting you to take legal action against them as soon as possible.
