Sub-Complaint for lodging FIR.

Respected Sir,

I, ASI Ananta Kr Dey PS do hereby submit complaint against arrested accused persons namely (1) Sk Manu@Manuruddin(26),s/o-Sk Gulsan of vill-Hutmura, PS-Purulia(M),Dist-Purulia,(02) Sk Hafizul @ Godu(26),s/o-Sk Yasin of vill-Kustuka, PS-Purulia(M),Dist-Purulia and also produced seized articles as per seizure list to the effect that on 13.10.22 during day mobile duty vide Purulia(M) PS GDE No-524 Dtd-13.10.2022 and CC No-3693/2022 Dtd-13.10.2022 on Purulia-Ranchi road with Govt vehicle having no-WB56CE/5423 and at about 12.35 hrs I, received a telephonic information from a reliable person that two vehicles loaded with cow were coming from Chas more side without any valid documents or proper permission from concern authority. The matter was intimated to I/C Purulia(M) PS and as per his kind instruction I along with my accompanied force C/692-Ukil Mahato, C/248-Arabinda Roy all of Purulia(M) PS rushed to Imundih Tri crossing point on Purulia-Ranchi road (NH32) and at 12.45 hrs I managed to stop the two(02) vehicles bearing Regd No-(01) WB37C/2660,(02) WB55B/2957 and found that total Cattles(Cows) 10 were loaded in the vehicles (details are mentioned in the attached seizure list)

On being asked, they revealed their identity as noted above but their identities could not be verified as they could not produce any relevant document in respect of their address and age. On demand, they could not produce any papers in respect of the vehicle or the Cattles, and about the procurement of the cattle or vehicle. Not only that they have not any paper regarding transportation of the Cattles etc. The vehicle is not meant for transporting livestock as no livestock permit was available. They did not give satisfactory reason for transporting of Cattles by vehicles. They have stated incoherently and from their statements there is every reason to believe that they have procured the vehicle and the cattle in any fraudulent means or by means of theft after hatching up criminal conspiracy also trying to disburse those Cattle for personal gain. Moreover, they were carrying those cattle in the vehicle in such a manner that those cattle were concealing together for the want of space. The above noted accused persons treated the cattles (Cows) in such a manner so as subject those to unnecessary cruelty as they loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth. Hence, I seized those total ten (10) Cattles (Cows) and the two vehicles noted above from the possessions of the above noted accused persons under proper seizure list in between 13.05 hrs and 13.45 and after seizure I also arrested them at 13.55 hrs and 14.05 hrs as they committed offence U/S- 379/411/414/120B IPC and U/S-11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960. After that I brought the arrested accused persons by maintaining all formalities regarding arrest with the help of my accompanied officers and force. The vehicle is not meant for transporting the cattle also. The cattle were illegally being transported from other states for the purpose of illegal inter-state cattle smuggling. It is to be noted here that we were waiting for public witness and after a lapse of time no public witness could be available there and hence my accompanying Police party stood seizure witness.

I, therefore pray that a case may kindly be started against the arrested accused persons noted above and owner of the those vehicles and others U/S- 379/411/414/120B IPC and U/S-11(1)(d) (e)(f) the prevention of cruelty to Animal Act 1960 and arrange its investigation.
