

In producing herewith the accd. person namely Sk. Jakir @ Kota (37 yrs) S/O Sk. Janu @ janmahammad of Vill-Hutmura, PS-Purulia(M), Dist-Purulia under proper memo of arrest along with related documents. The following seized articles (i) One improvised country made iron made fire arms having barrel, butt, trigger and firing pin having a length of 9.9 inch (approx.) (ii) One live cartridge ammunition of length 3 inch (approx.). I, SI Bapan Mondal of Purulia (M) PS received a source information that one namely Sk. Kota kept illegal weapon at his new house at Hutmura Bazar under Purulia (M) PS. I informed I/C Purulia (M) PS regarding the source information and as per his direction myself along with SI Abhijit Singh and force and also On duty Mobile Officer ASI Partha Sarathi Murmu and forces (i) C/350 Subodh Kumar Bouri & ii) NVF-268-Gunodhar Singh both of Purulia (M) PS left for vide Purulia (M) PS C.C No- 3726/2022 dtd 16.10.2022 and C.C No- 3730/2022 dtd 16.10.2022 and GDE No- 678 Dt. 16.10.2022 to work out the source information.

I along with force reached at the Hutmura Bazar and as per identification of my source myself along with force reached in front of the house of Sk. Kota and found that the house is locked from the inside. Several times I request for opened the door but no one heeds my request. So, I called the local administration (Panchayat) to help us . Somehow we managed to break the door in front of the local panchayat members and other witnesses and found one person is in side of house. I asked his identity and then he disclosed his identity that which is noted above. There after disclosing my identity as SI Bapan Mondal of Purulia (M) PS I and force offered him to search of his house as well as his body in presence of the local witnesses but he denied to do so. When the suspected person refused to search we started searching him and his house on searching I recovered the above noted fire arms loaded with one live ammunition from drawer of one iron Amirah. On asking he failed to produce any valid documents and papers in favour of that fire arms and ammunition. He also failed to give satisfactory answer for keeping this arms and ammunition in his house. I seized the arms & ammunition under proper seizer list which was duly signed by the accused person as well as local available witnesses. I unloaded the live ammunition from the said fire arms and seized the arms and ammunition in between 11:25 to 11:45 hrs under proper seizure list and also labelled it in presence of witnesses . After the seizure I arrested the accused person and issued arrest memo, observing all legal formalities as laid down by Hon'ble Supreme Court regarding the arrest of Sk. Jakir @ Kota (37 yrs) S/O Sk. Janu @ janmahammad of Vill-Hutmura, PS- Purulia (M), Dist- Purulia comes under per view of Indian Arms Act. After that myself along with force with seized articles and arrested accused person returned to PS.After returning at PS,I searched PS record against the arrested Accused person and found that 04 (Four) Warrant of Arrest which reference are-1) Purulia(M) PS Case No-174/11, Dt-22.09.11, u/s-399/402 IPC & 25/27 Arms Act having GR No-1016/11 2) Purulia(M) PS Case No-116/13, Dt-17.07.13, u/s-394/411 IPC having GR No-781/13 3) Purulia(T) PS Case No-41/15, Dt-29.03.15, u/s-394/411 IPC having GR no-383/15, 4) Purulia(T) PS Case no-23/15, Dt-13.02.15,u/s-399/402 IPC having GR No-202/15 are laying pending since long.
