Sub:-Prayer for starting a specific case.

Respected Sir,

In producing here with two(02) arrested accused persons namely (01) Md Abdul Ansary (30), s/o-Jamal Ansary (02) Biplab Mahato (24), s/o-Higulal Mahato, both of Vill-Lonka, PO-Ghaghari, PS-Chandankiyari, Dist-Bokaro, Jharkhand, PIN-828134 & along with seized motor cycle , Seizure list, Memo of Arrest of the above noted persons before you, I would like to note here that I SI Srikanta Mula (36 yrs) presently posted at Purulia (M) PS under your kind control, would like to draw your kind attention that today (29.10.2022) while myself long with C/611-Jitendranath Pathak, C/178-Tulsi Mahato of Purulia (M) PS, vide Purulia (M) PS C.C No-/2022 and GDE No-1233 Dtd-29.10.2022 & CC No-3840/22 Dtd-29.10.2022 were engaged mobile duty towards Ranchi road side under Purulia(M)PS and as per order of I/C Purulia (M) PS were checking the Naka at Imundih Tri crossing near Pandey Hotel on NH32 road, at about 12.00 hrs. I found one motorcycle without number plate was coming from Chas more side in high speed & we raised hand and directed to stop the motor Cycle but said Motor Cycle rider violated the Police Signal endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user and went towards Purulia side. Then we chased them with our Govt vehicle and could be able to detain the driver & pillion rider at Belkuri more on NH32 road and they identified themself as noted above and asked them to produce the valid papers in respect of said motor cycle and also asked him why he drove motor cycle in such manner but he (driver) did not show any papers. I repeatedly asked the driver to produce the valid paper but the driver & pillion driver stated difference statement in different times. In the meantime both driver & pillion rider started hue and cry and also abused us in filthy languages and suddenly attacked upon us, restrained wrongfully and challenged my authority and also assaulted us with fist and blows and deterred me to perform my lawful Govt duty. As a result I received bleeding injury on my left hand and one C/611-Jitendranath Pathak received bleeding injury on his left hand. At that time I seized the said motor cycle TVS Zider having Engine no-AF9KN1407455 & Chasis no-MD625AF95N1K09959 & black & navy blue in colour in between 12.15 hrs & 12.35 hrs from the driver and then I arrested them at 12.45 hrs & 12.55 hrs, informed them the ground of arrest and all formalities. Thereafter I arranged for Medical treatment of us at Purulia Govt. Medical College & Hospital.

Under this circumstance I therefore am requesting you to treat my complaint as FIR and arrange for its investigation.
