Sub:-Prayer for starting a specific case against namely Uttam Mondal (52),s/o-Lt. Satish Mondal Paul A/P vill-Kustaur, PS-Purulia(M), Dist.-Purulia (Resident of Vill-Alitha, PS-Chhatna, Dist-Bankura.

In producing herewith one accused person namely Uttam Mondal (52),s/o-Lt. Satish Mondal Paul Respected Sir, A/P vill-Kustaur, PS-Purulia(M), Dist.-Purulia (Resident of Vill-Alitha, PS-Chhatna, Dist-Bankura) under arrest and the following seized articles under seizure list enclosed herewith:

- 1) Eight (08) sealed plastic bottles(CS) containing 600ml each and labelled with DILKHUSH.
- 2) One big bag.
- 3) One taru chat.

I ASI Biswajit Kalindi of this PS do hereby lodge this complaint regarding that today (01.10.2022) at about 13.15 hrs during my Spl. raid duty at Kustar more received a source information over telephone that the above noted accused person has been selling CS liquor illegally and clandestinely at his Hotel stylise as Maa Hotel at Kustar more under Purulia(M)PS. On receiving the reliable source information I communicated with I/C Purulia (M)PS over telephone and as per his instruction I along with C/768-Ajit Kr Murmu, C/2734-Susanta Kr Panda both of Purulia (M)PS rushed to the spot to work out the information. On arriving to the spot at 13.25 hrs I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure and labelled the seized articles duly signed by the accompanying party and accused in the seizure list and the label in between $14.05~\mathrm{hrs}~\&$ 14.25 hrs. One bottle 600 mlliquor has been kept as sample taken from that seizure as sample which was also duly labelled and also took signature of the accompanying witness & accused on seizure list and label .After this I arrested that accused person namely Uttam Mondal (52),s/o-Lt. Satish Mondal Paul A/P vill-Kustaur, PS-Purulia(M), Dist.-Purulia (Resident of Vill-Alitha, PS-Chhatna, Dist-Bankura) after preparing proper memo of arrest at 14.35 hrs.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
