Sir,

In producing here with 03 (three) arrested accused persons namely (1) Parvez Khan, (19 years) S/O- Mustak Khan of Digudipara, Ward No-08, P.S- Purulia (T), Dist- Purulia , (2) Mahammad Hassan @ Laddu (19 Years) S/O- Mahammad Irfan of Katin Para, Ward No-22, P.S- Purulia (T), Dist-Purulia (3) Sk. Inam (19 Years), S/O- Md. Aslam of Taldanga, J.K College Road, P.S- Purulia (T), Dist-Purulia A/P- Katin Para, Ward No-22, P.S- Purulia (T), Dist-Purulia and seized articles (1) One sword with wooden butt length approx 30 inch out of which 24 inch sharpen portion and 6 inch butt (2) One Iron made Rod length 42 inch lodged complaint against them and 01 others to the effect that on 20.10.22 at about 21:45 hrs received a credible tip that a gang of dacoits being armed with deadly weapons assembled at Nodiha Nak kata kali Mandir ground, Near Dulmi Bandh, Ward No 07 of Purulia Municipality and they were preparing themselves for committing dacoity at Nodiha. Accordingly I ASI Nayan Ch. Mandal of Purulia(T) PS informed the matter to I/C Purulia (T) PS over phone and contacted with all night patrolling officers, briefing to all I immediately along with source and C/1098 Tarani Sing Sardar, (2) C/1479 Anup Mahato vide Purulia (T) PS C.C. No. 694/22 dated- 20.10.22 and GDE No- 1033 dated- 20.10.22 left to work out the information by a Govt. vehicle, and reached near Nodiha Prantik Club at 22:05 hrs leaving the Police vehicle No. WB 56D 9024 and started to proceed for the anticipated place on foot. At 22:25 hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that a gang of 10/12 persons assembled at Nodiha Nak kata kali Mandir ground, Near Dulmi Bandh and those persons were whispering from which it was clear that they were preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed to ours words and tried to flee away. We succeeded to nab in rounding up only 03(three) of them at 22:35 hrs while the rest were managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them that we want to search them and if necessary they can search us, but they informed us that they are not willing to search us. Then after observing all formalities I searched the above noted apprehended persons and discovered (1) One sword with wooden butt length 30 inch out of which 24 inch sharpen portion and 6 inch butt from the possession of Parvez Khan, S/O-Mustak Khan of Digudipara, Ward No-08, P.S- Purulia (T), Dist- Purulia (2) One Iron made Rod length 42 inch from the possession of Mahammad Hassan @ Laddu (19 Years) S/O- Mahammad Irfan of Katin Para, Ward No-22, P.S- Purulia (T), Dist- Purulia . Then on 20.10.22 in between 22:45 hrs to 23:05 Hrs from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities I, seized (1) One sword with wooden butt length approx 30 inch out of which 24 inch sharpen portion and 6 inch butt (2) One Iron made Rod length 42 inch under proper seizure list as well as labelled duly signed by the apprehended persons and witnesses as Alamat property in c/w above reference case. Then from 23:15 hrs to 23:25 hrs I arrested **03 (three)** persons (1) Parvez Khan, (19 years) S/O- Mustak Khan of Digudipara, Ward No-08, P.S- Purulia (T), Dist- Purulia, (2) Mahammad Hassan @ Laddu (19) Years) S/O- Mahammad Irfan of Katin Para, Ward No-22, P.S- Purulia (T), Dist- Purulia (3) Sk. Inam (19 Years), S/O- Md. Aslam of Taldanga, J.K College Road, P.S- Purulia (T), Dist- Purulia A/P- Katin Para, Ward No-22, P.S- Purulia (T), Dist- Purulia Issued Memo of arrest and observe all

legal formalities of arrest, also inform them regarding ground of arrest and inform to their family members. On interrogation they confessed their guilt and they stated that they have assembled there along with associates namely Taiyab Ansari, S/O- Aub Ansary of Katin Para, Ward No-22, P.S-Purulia (T), Dist-Purulia and others for committing house dacoity at Nadiha.

I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place and I got information they assembled and making preparation for committing dacoity armed with deadly weapons which might be dangerous for life of public witnesses, so I restrained collecting witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested them preparing arrest memo and ground of arrest were duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely (1) Parvez Khan,(19 years) S/O- Mustak Khan of Digudipara, Ward No-08, P.S-Purulia (T), Dist-Purulia, (2) Mahammad Hassan @ Laddu (19 Years) S/O- Mahammad Irfan of Katin Para, Ward No-22, P.S- Purulia (T), Dist-Purulia (3) Sk. Inam (19 Years), S/O- Md. Aslam of Taldanga, J.K College Road, P.S- Purulia (T), Dist-Purulia A/P- Katin Para, Ward No-22, P.S-Purulia (T), Dist-Purulia along with associates namely Taiyab Ansari, S/O- Aub Ansary Katin Para, Ward No-22, P.S- Purulia (T), Dist-Purulia and others under proper section of law.
