Sub: Prayer for starting a specific case against one Kuldip Gorai (27 yrs), S/O- Subodh Gorai, of Village- Pupunkee, Jolhadih, P.O- Pupunkee Ashram, P.S- Chas Muffasil, Dist- Bokaro, Jharkhand (Driver of Bolero Pick up Regd. No- JH09AJ4093)

Respected Sir,

With due respect I PSI Ashoke Mahata, beg to submit before you that on 28.10.2022 at about 15:15 hrs while myself along with C/470 Somnath Nag and NVF/892 Rupsing Besra, were performing Bank mobile & Naka Checking duty vide Purulia (T) PS CC No-2855/22 Dated-28.10.2022 at Judge Banglow on Purulia-Ranchi Road (NH-32). I found one Bolero Pick up having Regd. No- JH09AJ4093 was coming from Purulia side towards Joypur with Driving Dangerously. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Bolero Pick up but said Bolero Pickup driver violating the Police Signal and endangering the human life rush and negligently driving the Bolero Pickup which may cause any time accident to the road user. After long chase we can able to apprehend him near Judge Banglow. On interrogation he made incoherent statement at different time. He disclosed his identity as Kuldip Gorai (27 yrs), S/O- Subodh Gorai, of Village- Pupunkee, Jolhadih, P.O- Pupunkee Ashram, P.S- Chas Muffasil, Dist- Bokaro, Jharkhand. On being asked he failed to produce any other valid documents of Bolero Pickup. Hence he violated the provision of Section 279 IPC & R/W Section-181/184 MV Act. So I seized the One Bolero Pickup FB 2WD BS IV Bearing Regn No- JH09AJ4093, Chassis No- MA1ZN2TBKH1K75303 Engine No- TBH1K94981, in-between 15:35 hrs to 15:55 hrs under proper seizure list duly signed by the witnesses and arrested the offending driver namely Kuldip Gorai (27 yrs), S/O- Subodh Gorai, of Village- Pupunkee, Jolhadih, P.O- Pupunkee Ashram, P.S- Chas Muffasil, Dist- Bokaro, Jharkhand at 16:05 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailable hence accused driver namely Kuldip Gorai was released on bail.

So I pray specific case may kindly be registered against the accused namely Kuldip Gorai (27 yrs), S/O- Subodh Gorai, of Village- Pupunkee, Jolhadih, P.O- Pupunkee Ashram, P.S- Chas Muffasil, Dist- Bokaro, Jharkhand (Driver of Bolero Pick up Regd. No- JH09AJ4093) for committing offence U/S-279 IPC & R/W Section-181/184MV. Act.
