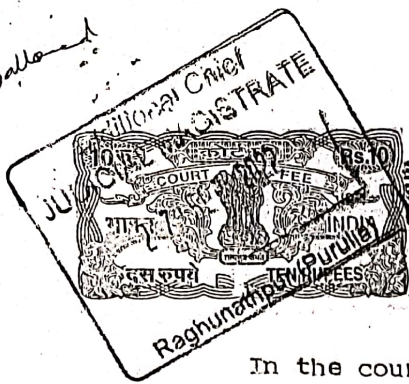

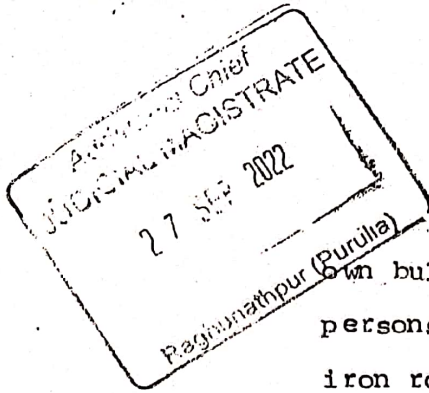

own bullock pair and plough at that time all the accused persons forming an unlawfull assembly being armed with lathi iron rod entered into the land of the compet with a view to fulfill their oblique intention their/dispossess the complt from his khas property stated assaulting the complt with fist & blows . Amongst the Accused persons ~~Maya~~ Sanjay Mahato cought hold and pressed the neck of the complt .At this junture son of complt found the screaming reached the P.O. tried to same his father ,but Accd. persons were so furious that gave out threat "TODER DUJONKEI MARE SESH KORE DEBO SALA. EKHANEI MATITE PUNTE DEBO KEO BACHATE PARBENA" EAI JAMIR JONYA AMRA SAB KICHU KARTE PARI. Accd namely, Shyamapada Gurupada and Nayan Mahato mercilessly beat up the bullock pair of the complt. with lathi and ultimately the accd.persons took away the bullock pair from the culch es of the complt Accd persons also ranshaked the paddy field by turning the seedlings. Be it noted after vigorous search complt found his bullock pair in a remote place.

3. That accd.persons are very much farious in nature and all time trying to do mischief with the persons & property of thecomplt and they are still giving out threat the complt in the locality with their high handed action.

4. That the complt. reported the matter to the local police station at Raghunathpur on 26/08/2022 but nothing yeilded hence complt. sent his complaint to the S.P.Purulia on 29.09.2022 but till day no action has been taken against the aced. person . Thus finding no other alternative taking the last recoruse complt comple to file instant petition before Ld. Court .

Therefore prayed that Ld.court may graciously be pleased to direct the I/C, Raghunathpur Police station p/3....
