Sir,

In producing here with the arrested accused persons namely (1) Gorakh Yadav (50) S/o Sidhi Yadav of Chunidar, PS - Semri, Dist.- Boyer, Bihar and (2) Sashi Sekhar Kumar (28) S/o Achchaylal Singh of Vill.- Madarhang, PS - Charpokhari, Dist.- Bhojpur, Bihar along with one white colour Bolero Pick up van bearing Reg. No. BR 44GA/4144 loaded with 07 (Seven) Cattles (04 Female Cows, 01 Female Buffalo, 01 Calf and 01 Buffalo Calf) to the effect that today (13.10.2022) during evening mobile duty at around 20:15 hrs when myself SI Subhas Malik of Raghunathpur PS along with C/1274 Ganesh Ch. Saha, C/600 Amit Shit and C/312 Radheshyam Mandal vide C.C. No. 3093/22 reached at Pakori more, found one Pick UP Van was running from Rukni side and was headed to Chelyama side with excessive speed and accordingly we intercepted the vehicle and found one person was on the driver's seat and another was beside him and there was none except them. In their presence I found that the vehicle bearing Reg. No. BR 44GA/4144 was loaded with total 07 (Seven) Cattles of different size. On asked they revealed their identity as noted above but their identities could not be verified as they could not produce any identity prove document. On demand they could not produce any papers in respect of the vehicle as well as the 07 (Seven) Cattles and about the procurement of the Cattles as well as the vehicle they stated incoherently and from their statements there is every ground to believe that they have procured the vehicle and the Cattles in any fraudulent means or by means of theft and was trying to conceal them. Moreover they were carrying those Cattles in such small vehicle in such a manner that they were huddling together for the want of space and Cattles may got injury. The above noted accused persons treated the Cattles in such a manner so as subject those to unnecessary pain as they loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth. Hence I seized those 07 (Seven) Cattles and one white colour Bolero Pick up van bearing Reg. No. BR 44GA/4144 from 20:45 hrs to 21:20 hrs from the possessions of the above noted accused persons under proper seizure list where the description of each Cattles is mentioned and after seizure I arrested them after maintaining all formalities regarding their arrest. It is to be noted that there is no public witnesses available due to lonely place and night hours hence my accompanying police forces stood witnesses. After that I brought the arrested accused persons, seized vehicle and the seized Cattles to PS.

I, therefore pray that a case may kindly be started against the arrested accused persons along with seizure articles under proper section of law and arrange its investigation.
