Respected Sir,

In producing herewith 01 (one) accd person Paltu Modak (51), S/O - Lt. Shyamapada Modak of Singh Basti near Kali Mandir, PS-Santaldih , Dist - Purulia along with seized articles (1) 07 packets of fire crackers, styled as 'CHUT PUTU' AH Fire work, (2) 02 packets of 'DIL CHOCOLATE', styled as carackers, (3) 02 Packets of 'SAI BALAJI FIRE WORKS, SIVAKASI' crackers, (4) 01 packet of 'BIJLI CRACKERS' and (5) 01 Packet of 'Ptit Quebec' (Aloo bomb), with proper seizure list I beg to submit that today on 13.10.2022 at 18.15 hrs during performing mobile duty at PS area along with C/1556 Faizul Kabir and C/1457 Nityaranjan Rajwar vide Santaldih PS GDE No. 525, dtd. 13.10.2022 and CC no. 3663/22 dated - 13.10.2022, I received an information from my source that a huge number of fire crackers have been sold by above noted person at his shop 'Modak Store' near STPS Gate no. 1 under this PS. I informed the matter to you and as per your kind order, had been to the above noted place with evening mobile officer ASI Rabindranath Basak, Constable-1406 Rajkumar Lohar and C/2028 Biswajit Roy . I parked the vehicle in a reasonable distance and cordoned the above noted shop by force. I detained 01 person and on asked he disclosed his identity noted above and identified himself as the owner of the above noted shop. I searched the shop of above noted Paltu Modak in presence of local disinterested witnesses and seized the above noted fire crackers from his shop . I asked him to produce relevant documents regarding the said crackers but he failed to produce in favour of keeping, storing or selling of such combustible or fire articles. On asked he also confessed his guilt regarding committing of offence.

It is noted here that Honble High Court Calcutta passed an order in WPA (P) 292 OF 2021 with I.A. No. CAN 1 of 2022 dated 11.10.2022, Sabuj Mancha and Anr Vs The State of West Bengal and others regarding prohibition of selling of firecrackers and directed the police personnel for its strict compliance.

Hence I pray before you to start a case in this respect under proper section of law and arrange its investigation.
