Sub : Prayer for lodging FIR against accused Kistapada Gorain (52 yrs) S/O – Lt. Barun Gorain of Vill. - Ichhar, PS-Santalaldih Dist- Purulia, U/S 46 A (c) Bengal Excise Act, 1909.

Sir,

In producing herewith one arrested accused person named as Kistapada Gorain (52 yrs) S/O – Lt. Barun Gorain of Vill. - Ichhar, PS-Santalaldih Dist- Purulia along with seizure – list and seized items as described below, I beg to state that on 20.10.2022 at about 05.05 hrs during night mobile duty I received a source information to the effect that the country spirit (**Dil Se**) has been kept at Ichhar village under this PS in the house of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and as per order of I.C Santaldih P.S. I along with force left for Ichhar to workout the information with the govt. supplied kit box containing white cloth; sealing wax, seal, papers, carbons, match box, candles etc. I had been to the house of Kistapada Gorain at Ichhar village, P.S. Santaldih at about 05.25 hours. Seeing police party some unknown persons in front of the house of Kistapada Gorain were fled away. However, I could detain one among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the country spirit (**Dil Se**) for selling and he was the owner of the said house. However, I along with said accused started a search inside the house of Kistapada Gorain and found the following item in the said house -

1) 17 (Seventeen) bottles 80UP country spirit (Dil Se) each bottles containing 600 ML.

01 (one) bottle of 600 ML taken (**Dil Se**) out of the above as sample packet, labeled and sealed with sealing wax.

I interrogated him about the purpose of the stocking and possessing such country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.


As such, I seized the above items as ALAMAT under proper Seizure List between 05.05 hrs and 05.25 hrs & took up one bottle of each brand as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit illegally without any valid papers in his house has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 06.25 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused Kistapada Gorain (52 yrs) S/O – Lt. Barun Gorain of Vill. - Ichhar, PS-Santalaldih Dist- Purulia.
