Sir,

In producing here with 123.62 M.T. coal brought at PS by various hired vehicles under proper seizure, I SI Sujit Kr. Majhi of Santaldih PS beg to submit that today (30/09/2022) at 14.35 hrs received a credible source information about illegal coal stocking at Paharigora more, opposite to the premises of Amrit tea shop. Accordingly I informed the matter to IC Santaldih PS and as per his direction, I along with C/1457 Nityaranjan Rajwar, C/1221 Yudhistir Kumar and being accompanied by evening mobile officer ASI Dharamdas Rajak and force of Santaldih PS vide Santaldih PS C.C No. 3477/22 dated-30.09.2022 and Santaldih PS GDE No. 1083 dated 30.09.2022 went out for executing the information. At about 14:55 hrs when we reached at Paharigora more, opposite to the premises of Amrit tea shop, we found that a huge quantity of steam coal is being stocked at this place. Seeing the Police party from a distance the persons present there were fled away from the spot. We chased them but could not able to intercept them. I searched the place and its adjacent area but no owner of the said coal turned up or nobody produced any valid document regarding the said coal. During local enquiry it is revealed that the coal was stocked by (i) Ramlal Mahato, S/O Lt. Basudeb Mahato of Vill.- Bogradih, PS - Santaldih, Dist. – Purulia and (ii) Manbodh Ojha, S/O Lt. Nibaran Ojha of Vill. – Mamarkudar, PS – Chas, Dist. – Bokaro, Jharkhand. The coal was approximately 110 M.T. After finding no other alternative I seized the coal approx 110 MT steam coal in between 15:25 hrs to 15:45 hrs under proper seizure list in presence of witnesses duly signed by them. As no public witness was available there hence only police witness have put signature on the seizure list. I have also seized 1 KG coal from the said seized coal as sample.

After that we arrange for transporting the coal from the PO and send to weigh bridge to weigh the actual quantity of coal by arranging local vehicles on hire. On its weighing it is calculated as 123.62 MT. After that we brought the seized coal at Santaldih PS and kept it at PS compound. On secret enquiry through my reliable source it came to light that the above noted persons have with their full knowledge running this clandestine business by means of stocking and selling or supplying of coal for their wrongful gain.

Hence I do here by lodge this complaint with a prayer that a specific case may be started against above noted (i) Ramlal Mahato, S/O Lt. Basudeb Mahato of Vill.- Bogradih, PS – Santaldih, Dist. – Purulia and (ii) Manbodh Ojha, S/O Lt. Nibaran Ojha of Vill. – Mamarkudar, PS – Chas, Dist. – Bokaro, Jharkhand under proper section of law and arrange for its investigation.
