Sir,

I, Shri Sekhar K.r Mitra , Inspr. of Police, DEB Purulia do here by lodged a complaint against one Sukumar Mandal (31) S/O Magaram Mandal of vill-Sadhusaltora, P.O- Tarabari, P.S-Santuri Dist-Purulia along with following seized articles viz

- 1) 02 Basta PDS Rice sealed condition- Weight @ 50X2 =100 Kgs (Approx)
- 2) 04 Basta PDS Wheat sealed condition -Weight @ 50X4 =200 Kgs (Approx)
- 3) 02 Basta PDS Atta sealed condition -Weight @ 47.5X2 =95 Kgs (Approx)
- 4) 51 Packets Atta -Weight @ 950 gmsX51 =48 Kgs 450 gms (Approx)
- 5) 04 Basta PDS loose Atta (without packets) -Weight @ 55.5 X4 =222 Kgs (Approx)

to the effect that today on 11/10/22 on the basis of secret and credible information I, Shri Sekhar Kr. Mitra, Inspr. of Police, DEB Purulia along with SI Amaresh Das, ASI Prabir Mukherjee, C/88 Pradut Kumar Mondal, HG/1427 Benimadhab Char had been to the Santuri PS and submit a requisition to O/C Santuri PS for rendering assistance and noted the credible information at Santuri PS at 12:15 hrs vide Santuri PS GDE no. 363 dated 11/10/22. Thereafter, ASI Animesh Pati and force of Santuri PS and myself along with my team of DEB Purulia left for Sadhusaltora under Santuri PS to work out the information by availing Govt. vehicle bearing No. WB 56M/8203 . On arrival at Sadhusaltora to work out the information two local people viz (1) Chhotan Bauri S/O Lt. Gobinda Bauri & (2) Basu Bauri S/O- Rabi Bauri both of Vill-Saloni P.S-Chhatna Dist-Bankura to assist us for holding raid, search and seizure in the shop of Sukumar Mandal S/O Magaram Mandal of vill-Sadhusaltora P.O-Tarabari, P.S-Santuri Dist-Purulia. Thereafter myself along with accompanied officers and force and with the active assistance of above noted two witnesses held raid in the paddy go down shop of Sukumar Mandal after observing all formalities as laid down in Section 100 of Cr.PC 1973 relating to search & seizure. Prior to hold raid in the shop we noticed huge number of PDS Rice, PDS Atta and PDS wheat staged inside the room of paddy go down shop. The shop owner namely Sukumar Mandal asked to produced valid documents / license for running his business in respect of possessing PDS Rice, PDS Atta and PDS wheats but the shop owner failed to produce any valid documents/ license for running such illegal business. As such I seized the articles as mentioned above and in the seizure list in presence of local witnesses and Police witnesses under proper seizure list from the paddy go down shop of Sukumar Mandal .

As Sukumar Mandal failed to produce any valid documents/ license for running such business, hence he violated provisions laid down in Para 7 of rule 3 of West Bengal. Thus he committed an offence punishable U/S- 7 (1)(a)(ii) of E.C (X) of Act 1955 against owner Sukumar Mandal accordingly

In course of local enquiry it revealed that said Sukumar Mandal is running clandestine business of PDS goods since long without having any authority or license and only for causing his wrongful gain and deprived poor local consumer/customers as well as causing loss of revenue to the Govt.

I therefore request you to start a case U/S 7 (1)(a)(ii) of E.C (X) of Act 1955 against Sukumar Mandal (31) S/O Magaram Mandal of Vill-Sadhusaltora, P.O-Tarabari, P.S-Santuri Dist-Purulia



Manik Lal Chandra of Vill- Raghunathpur, Tantipara PS-Raghunathpur, Dist- Purulia vide License No- PUR-RGH-274, who was recommended by the owner of MR distributor namely "Suprava Chadra" after taking proper zimmanama in anticipation of kind approval of the Ld. ACJM Court Raghunathpur.

As per kind direction of S.P DEB Purulia the case will investigate ASI Swapan Chakraborty of DEB, Purulia.
