Respected Sir,

In producing herewith 01 (one) accd person namely Sakshi Gopal Mitra (47 Yrs), S/O- Nirmal Kr. Mitra of Vill-Balitora, PS-Santuri, Dist-Purulia along with seized articles **1) 05 (Five) packets of fire crackers containing 10 Pcs each, styled as 'BLACK CAT CHOCOLATE BOMB'** **2) 15 (Fifteen) packets of fire Crackers containing 10 Pcs each, styled as 'DULALS CHOCOLATE BOMB'**, **3) 10 (Ten) packets of fire Crackers containing 100 Pcs each, styled as 'Turkey Bijill'** with proper seizure list, I beg to submit that today on 16.10.22 at 18:15 hrs during my mobile duty at Muradih Bazar received an information from one of my reliable source that a huge number of illegal/banned fire crackers have been stored by above noted person at his shop at Madhukunda Bazar under this PS for selling it in clandestine manner for wrongful gain violating the direction of Hon'ble High Court, Kolkata. Accordingly, after taking verbal permission from O/C Santuri PS I along with force started to move to the anticipated place to work out the information. At about 18:45 hrs we reached at Madhukunda Bazar & held raid at the shop of above mentioned accused person as shown and identified by my source. I would like to note here that seeing the Police personnel, customers present at the shop at that time fled away. However I could detain 01 person and on being asked he disclosed his identity as noted above and pretended himself as the owner of the above noted shop. I held search at the shop of said Sakshi Gopal Mitra, S/O- Nirmal Kr. Mitra of Vill-Balitora, PS-Santuri, Dist-Purulia and could seize the above noted fire crackers from his shop after preparing proper seizure list duly signed by my accompanying force as there was no public witness available. I asked him to produce relevant documents for storage & selling of such illegal/banned fire crackers from his shop but he failed to produce any documents in favour of keeping, storing or selling of such fire articles & thereby he committed an offence u/s 188 IPC r/w Sec. 24 WBFS Act.

It is noted here that Honble High Court Calcutta passed an order in WPA (P) 282 OF 2021 Dtd 29.10.21 with LA No-CAN 1 of 2022 Dtd.-11/10/2022, Sabuj Mancha and Anr vs the State of West Bengal and others regarding prohibition of selling of firecrackers other than Green fire crackers and directed the police personnel for its strict compliance.

Hence I pray before you to start a case in this respect under proper section of law and arrange its investigation.
