Sub: Prayer for starting a specific case against one Papul Bauri (35 Yrs) S/o- Manik Bauri of Vill- Gourangadih, PS-Kashipur, Dist-Purulia (Driver of Auto-Van having Regd. No-JH10AU4765).

Respected Sir,

With due respect I ASI Pallab Pandey, beg to submit before you that on 18/10/2022 at about 16:05 hrs while myself along with force were performing mobile duty at Hansdima More on Raghunathpur-Saltora Road (SH-8). I found one Auto-Van was coming from Saltora side towards Santuri side with driving at excessive speed. Police personnel, present their in proper Police uniform raised hand and directed him to stop the Auto-Van but the said Auto-Van, violating the Police Signal and endangering human life by rash and negligently driving the Auto - Van which may cause accident to the road user any time. After long chase we can able to apprehend him at Santuri More at 16:20 hrs. On interrogation he made incoherent statement at different time. He disclosed his identity as Papul Bauri (35 Yrs) S/o- Manik Bauri of Vill-Gourangadih, PS-Kashipur, Dist-Purulia. On being asked he failed to produce any valid documents of the said Auto-Van.

Hence he violated the provision of Section 279 IPC. So, I seized the Auto-Van having Regd. No- JH10AU4765 at 16:40 hrs to 16:50 hrs under proper seizure list duly singed by the witnesses and arrested the offending driver namely Papul Bauri (35 Yrs) S/o- Manik Bauri of Vill- Gourangadih, PS-Kashipur, Dist-Purulia at 16:55 hrs avoiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bailable, hence the accused driver namely Papul Bauri was released on bail after furnishing proper bail bond.

So I pray before you that a specific case may kindly be registered against the accused driver namely Papul Bauri (35 Yrs) S/o- Manik Bauri of Vill- Gourangadih, PS-Kashipur, Dist-Purulia of Auto-Van having Regd. No- JH10AU4765 for committing offence U/S-279 IPC.
