Respected Sir,

I, Sudhir Turu S/o- Lt. Jagannath Tudu of Vill - Tarpania, PO- Ranga, PS- Bagmundi, Dist- Purulia, ASI of Police of Tamna PS, Dist- Purulia along with force return to PS and brought seized one Red colour Mahindra B275 DI Tractor having Reg. No. WB55B-5581, having Engine No- RMH2EAN3962 & Chassis No- MBNABAEXKMRH07858 attached with trolley loaded with sand approx. 80 cft. and lodged this complaint to the effect that today i.e on 11.10.2022, myself along with force i) C/293 Subhasis Chakraborty and ii) C/391 Satya Sundar Kundu were performing PS area evening mobile duty vide Tamna PS GDE No- 414 date- 11.10.2022. During my mobile duty at about 07.55 hrs received credible source information that one Red colour Tractor is loading sand illegally from Kangsabati river near Baligara Pump House. Accordingly, myself along with force left to work out the said source information. Then, we intercepted the aforesaid tractor on the river bed of Kangsabati river near Baligara Pump House under Tamna PS, Dist- Purulia at about 08:35 hrs and found that the above noted tractor was tagged with a trolley loaded with sand (approx. 80 cft.). But seeing the Police party, driver and 02 others of the tractor fled away leaving the said tractor on the river bed of Kangsabati river near Baligara Pump House. We tried to apprehend them but failed. So, there is every reason to belief that the owner and driver of above noted tractor dealing in sand business in clandestine manner. We waited for reasonable time but none came forward and produce any proper challan or any valid documents related to the said sand lifting of above detained tractor. So, I seized the said Red colour Mahindra B275 DI Tractor having Reg. No. WB55B-5581, having Engine No- RMH2EAN3962 & Chassis No- MBNABAEXKMRH07858 attached with trolley loaded with sand approx. 80 cft. Bring the Tractor at PS after arranging driver from our source.

On return to Tamna PS, kept the aforesaid seized tractor attached with sand loaded (Approx 80 cft.) trolley at PS compound and I do hereby submit written complaint before you to start a cog case against the owner and driver of the Red colour Mahindra B275 DI Tractor having Reg. No. WB55B-5581, having Engine No- RMH2EAN3962 & Chassis No- MBNABAEXKMRH07858 attached with trolley loaded with sand approx. 80 cft. and 02 (two) others under proper section of law.
