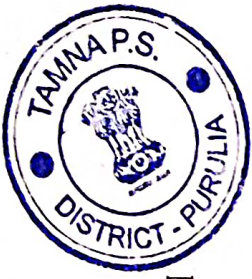

In producing herewith arrested offending driver namely Vivekananda Majhi (43 Yrs), S/O- Late Falguni Majhi of Vill- Mishirdih, P.O- Jhunjhka, PS- Arsha, Dist- Purulia along with one seized Red Colour Hero HF Deluxe Motor-Cycle bearing Registration No. WB56R/0797.


I, Jagannath Rakshit S/O- Subodh Ch. Rakshit of Vill- Paisabaid, P.O- Hatgram, PS- Chatna, Dist- Bankura at present posted at Tamna PS, Dist- Purulia as ASI of Police beg to report that today myself along with C/1454 Ashok Kr. Mahato and C/2671 Prasanta Rajak all of Tamna PS were performing anti-crime EP/NP mobile duty under Tamna PS vide Tamna PS CC No- 4762/22 Dtd- 13.10.2022 & Tamna PS GDE No. 529 Dtd- 13.10.2022 at 19:15 hrs. at Tamna More under Tamna PS, Dist- Purulia, I found one Red Colour Hero HF Deluxe Motor-Cycle bearing Registration No. WB56R/0797 was coming from Simulia side rashly and negligently. We try to stop him but the driver of the said motor cycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop the said motor cycle near Tamna More under Tamna, Dist- Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested the above noted person under proper memo of arrest after disclosing the ground of his arrest and also observing all legal formalities regarding arrest as he violated Sec. 279 IPC. I also seized the Red Colour Hero HF Deluxe Motor-Cycle bearing Registration No. WB56R/0797 in presence of witnesses and informed him and his relatives regarding the ground of arrest.

Therefore, I pray that a specific case may kindly be started against the aforesaid driver namely Vivekananda Majhi (43 Yrs), S/O- Late Falguni Majhi of Vill- Mishirdih, P.O- Jhunjhka, PS- Arsha, Dist- Purulia.
