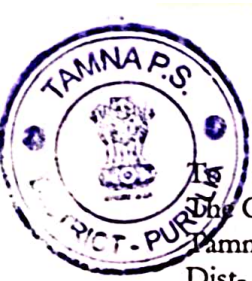

Sub: - Complaint for lodging FIR.

Sir,

I, Surajit Kr. Das, S/o- Samir Kr. Das of Vill- Kalipur Majhpara, PO- Karidhya, PS- Suri, Dist- Birbhum, A/P- SI of Police of Tamna PS do hereby submit complaint against arrested accd persons namely (1) Mir Javed (48 yrs) S/o- Lt. Mir Samsul Hoda of Vill- Sahinanv, PO- Babhnaul, PS - Dawath, Dist- Rohtas (2) Bablu Khan (22 Yrs.), S/o- Mir Javed of Vill- Sahinanv, PO- Babhnaul, PS - Dawath, Dist- Rohtas (3) Yadav Bharat (33 Yrs.), S/o- Sabhapati Ramkishan Yadav of Vill- Sonhani, PO- Sonhani, PS- Bhagwanpur Hat, Dist- Siwan and (4) Chotu Kumar (18 Yrs), S/o- Munna Singh of Vill- Bihari Bigha, PO- Dalmianagar, PS- Akorhigola, Dist- Rohtas all of state Bihar to the effect that on 14.10.22 during night mobile duty vide Tamna PS GDE No- 582 dtd- 14.10.2022 & CC No- 4775 dtd. 14.10.22 on Purulia-Tata road and on the night of 14/15-10.2022 at about 00.05 hrs I received a telephonic information from a reliable source that two vehicle loaded with cattle were coming from Balarampur side without any valid documents or proper permission from concern authority. The matter was intimated to O/C Tamna PS and as per his kind instruction I along with my accompanied force C/ 1336 Madhusudan Paramanik & C/572 Lakshmi Kanta Singha all of Tamna PS rushed to Tamna More on Purulia-Tata road (NH-32). I also called officers and force from PS and at about 00.25 hrs I managed to stop the 02 (two) vehicles bearing Registration No. 1. WB09-1482 and 2. WB11D-9857 and found that Total Cattles -13 (thirteen) like Buffalo-10 and Calf-03(three) were loaded in the above mentioned vehicles i.e. Buffalo- 05 & Calf-02 in vehicle No. WB09-1482 and Buffalo- 05 & Calf-01 in vehicle No. WB11D-9857.

On being asked, they revealed their identity as noted above but their identities could not be verified as they could not produce any relevant document in respect of their address and age. On demand, they could not produce any papers in respect of the vehicle or the Cattles, and about the procurement of the cattle or vehicle. Not only that they have not any paper regarding transportation of the Cattles etc. The vehicle is not meant for transporting livestock as no livestock permit was available. They did not give satisfactory reason for transporting of Cattles by vehicles. They have stated incoherently and from their statements there is every reason to believe that they have procured the vehicle and the cattle in any fraudulent means or by means of theft after hatching up criminal conspiracy also trying to disburse those Cattle for personal gain. Moreover, they were carrying those cattle in the vehicle in such a manner that those cattle were concealing together for the want of space. The above noted accused persons treated the cattle in such a manner so as subject those to unnecessary cruelty as they loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth. Hence, I seized those Total 13 Cattles and the vehicle noted above from the possessions of the above noted accused persons under proper seizure list and after seizure I also arrested them as they committed offence U/S- 379/411/414/120B IPC and U/S- 11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960. After that I brought the arrested accused persons by maintaining all formalities regarding arrest with the help of my accompanied officers and force. The vehicle is not meant for transporting the cattle also. The cattle were illegally transporting cattle from other states for the purpose of illegal inter-state cattle smuggling.

I, therefore pray that a case may kindly be started against the arrested accused persons noted above and owner of the those vehicles and others U/S- 379/411/414/120B IPC and U/S- 11(1)(d) (e)(f) the prevention of cruelty to Animal Act 1960 and arrange its investigation.
