I, Sudhir Tudu S/O- Lt. Jagannath Tudu of Vill- Tarpania, P.O- Ranga, PS- Bagmundi, Dist-Purulia at present posted at Tamna PS, Dist-Purulia as ASI of Police beg to report that today myself along with C/2671 Prasanta Rajak and HG/1815 Karamchand Kumar all of Tamna PS were performing anti-crime day mobile duty under Tamna PS area vide Tamna PS CC No- 4827/22 Dtd-19.10.2022 & Tamna PS GDE No. 779 Dtd- 19.10.2022 at 16:25 hrs. at near Tamna rail gate under Tamna PS, Dist- Purulia, I found one vehicle (Bollero Pick Up) bearing Registration No. JH05DC/9688 was coming from Chakaltore side on Purulia - Manbazar road (SH-05) rashly and negligently.
