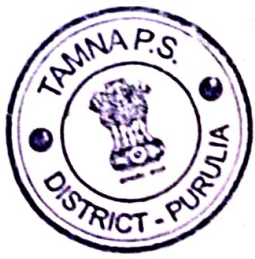


I, Nikhil Pratap Singh S/o- Shri Shivkumar Singh of Vill- Majhwalia, P.O- Majlishpur, PS- Kopa, Dist- Chapra (Saran), Bihar SI of Police PS Tamna beg to report that today myself along with NVF/571 Bhakta Ranjan Pramanik and HG/1903 Haripada Tudu all of Tamna PS were performing anti-crime day mobile duty under Tamna PS area vide Tamna PS CC No- 4850/22 Dtd- 26.10.2022 & Tamna PS GDE No. 1060 Dtd- 26.10.2022 at 16:15 hrs. at near Durku more under Tamna PS, Dist- Purulia, I found one Black colour Motor Cycle (Honda Dream Yuga) bearing Registration No. WB56P/8727 was coming from Purulia side on Purulia – Manbazar road (SH-05) rashly and negligently. We try to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop the said vehicle near at Durku more under Tamna, Dist- Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested the above noted person under proper memo of arrest after disclosing the ground of his arrest and also observing all legal formalities regarding arrest as he violated Sec. 279 IPC. I also seized the Black colour Motor Cycle (Honda Dream Yuga) bearing Registration No. WB56P/8727 in presence of witnesses and informed him and his relatives regarding the ground of arrest.

Therefore, I pray that a specific case may kindly be started against the aforesaid driver namely Adity Mahato (28 Yrs), S/O- Late Gour Ch. Mahato of Vill- Koradih, PS- Tamna, Dist- Purulia.


