In producing herewith arrested offending driver namely Sahabuddin Ansary (40 Yrs), S/O- Late Umer Ali Ansary of Vill+PO- Nadiyara, PS- Purulia(M), Dist- Purulia along with one seized Silver Colour Honda Shine Motor Cycle bearing Registration No. WB56T/3880.


I, Surajit Kumar Das S/O- Samir Kumar Das of Vill- Kalipur Majhpara, P.O- Karidhya, PS- Suri, Dist- Birbhum at present posted at Tamna PS, Dist- Purulia as PSI of Police beg to report that today myself along with NVF/571 Bhakta Ranjan Paramanik and HG/1815 Karam Chand Kumar all of Tamna PS were performing anti-crime day mobile duty on Purulia-Manbazar road side area under Tamna PS vide Tamna PS CC No- 4884/22 Dtd- 29.10.2022 & Tamna PS GDE No. 1182 Dtd- 29.10.2022 at about 13:15 hrs. at Chandradih More under Tamna PS, Dist- Purulia, I found one Silver Colour Honda Shine Motor Cycle bearing Registration No. WB56T/3880 was coming from Chakaltore side rashly and negligently. We try to stop him but the driver of the said motor cycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop the said motor cycle at Durku More near Tamna PS Kali Mandir under Tamna, Dist- Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested the above noted person under proper memo of arrest after disclosing the ground of his arrest and also observing all legal formalities regarding arrest as he violated Sec. 279 IPC. I also seized the Silver Colour Honda Shine Motor Cycle bearing Registration No. WB56T/3880 in presence of witnesses and informed him and his relatives regarding the ground of arrest.

Therefore, I pray that a specific case may kindly be started against the aforesaid driver namely Sahabuddin Ansary (40 Yrs), S/O- Late Umer Ali Ansary of Vill+PO- Nadiyara, PS- Purulia(M), Dist- Purulia.
