

I, Goutam Kr. Bangal S/o- Bangshi Bangal of Vill- Pratapbagan, Prantika, P.O + PS- Bankura (S), Dist-Bankura at present SI of Tamna Police Station, Dist-Purulia do hereby lodge this complaint as Suo moto against 10 (Ten) arrested accused persons namely 1) Kista Mahato (41 Yrs.) S/o- Fani Mahato of Dulmi Mahato Para, PS-Purulia (I), Ward No-06, Dist-Purulia, 2) Bikash Ch. Sharma (36 Yrs) S/o- Bharat Ch. Sharma of Vill-Bodro, PO-Alkusha, PS- Chas, Dist- Bokaro, Jharkhand A/P-Ambaresh Pally, Ward No- 18, PS- Purulia (I), Dist- Purulia, 3) Ram Sao (35 Yrs) S/o- Late Manua Sao of J.K. College Road, Ketika, Ward No-09, PS- Purulia (1), Dist- Purulia, 4) Nirmal Ch. Mahato (25 Yrs) S/o- Brindaban Mahato of Vill- Sirkabaid (Sagma), PS- Balarampur, Dist- Purulia, A/P-J.K. College Road, Ketika, Ward No-09, PS- Purulia (I), Dist- Purulia, 5) Bhajan Roy (36 Yrs) S/o- Niranjan Roy of Sarkar Para, Ward No- 19, PS- Purulia (T), Dist- Purulia, 6) Saroj Mahato (32 Yrs) S/o- Fani Bhusan Mahato of Vill-Simulia more, PS- Tamna, Dist- Purulia, 7) Laltu Mahato (32 Yrs) S/o- Dilip Mahato of Telkal Para, Ward No- 11, PS-Purulia (I), Dist-Purulia, 8) Raju Pal (27 Yrs) S/o- Lt. Bangshi Pal of Old Police Line, Ward No- 10, PS-Purulia (I), Dist-Purulia, 9) Sourav Mahato @ Gholtu (32 Yrs) S/o- Nepal Ch. Mahato of Dulmi-Nadiha, Ward No- 06, PS-Purulia (I), Dist-Purulia & 10) Bhajahari Mahato (40 Yrs) S/o- Haradhan Mahato of Vill-Raibandh, PS- Tamna, Dist-Purulia to the effect that on 29.09.2022 during while I was engaged in PS area Spl. Night mobile duty under Tamna P.S jurisdiction, received an information from reliable source that some persons were playing with cards inside a house at village Simulia on Purulia-Tata road near Simulia Smashan Kali Mandir under Sonaijuri G.P. After informed the fact to O/C of Tamna P.S and as per his direction myself along with ASI Gnan Sankar Pati, C-293 Subhasis Chakraborty and Spl. HG/1861 Dipak Kumar with the help of night mobile officers and force with the Govt. vehicles bearing Registration No- WB-36E/ 5832 & JH09Y/4081, left to work out the said source information. At about 00.05 hrs. when we reached in front of the house of Bhajahari Mahato at Simulia near Smashan Kali Mandir heard whispering of some persons from inside of the said house. We gheraoed the possible escaping place by standing our force. From the backside door we entered into the house and noticed that some persons were sitting in a round manner on the floor and playing among themselves with plying cards for their wrongful gain or loss and found huge amount of money on the board. Accordingly, I seized i) 06 packets of Playing card containing 52 pcs. each, ii) 04 (four) empty bottle XXX Rum @ 375 ml each iii) One Match Box, iv) 02 packets Cigarette, v) 05 packets of biri, vi) 02 packets of Gutkha & vii) Total Board money Rs. 1,29,330/- (One lakh twenty-nine thousand three hundred thirty only) (Rs-2000 x 1 + 500 x 228 + 200 x 8 + 100 x 114 + 50 x 2+20 x 4+10 x 14+ 10 rupees Coin x 1) under proper seizure list and arrested them one by one under proper memo of arrest on that spot. During arrest I observed all the guide lines of apex Court and. On interrogation all the arrested persons confessed the guilt and they informed that they came to this house as noted above and out of them one Bhajahari Mahato (40 Yrs) S/o- Haradhan Mahato of Vill-Raibandh, PS-Tamna, Dist-Purulia voluntarily confessed that he is the owner of the said house and arranged for used gambling purpose for whole night. During seizure no public witness were noticed except Police as such odd hours of night. Then I came to PS along with all the arrested persons and seized articles.

The above noted accused persons were committing offence u/s- 3/4 WBG & PC Act- 1957 as they admitted that they were playing with cards for their wrongful gain/loss purpose inside the house of one Bhajahari Mahato (40 Yrs) S/o- Haradhan Mahato of Vill- Raibandh, PS- Tamna, Dist- Purulia at Simulia near Smashan Kali Mandir under Tamna PS, Dist- Purulia.

I therefore requesting you to treat this complaint as FIR and kindly start a case against the above 10 (Ten) arrested persons under proper section of law and obliged.
