In producing herewith 04 (Four) accused persons namely 1) Md. Aslam (25 Yrs), S/O-Lt. Md. Jalil 2) Md. Miraj (35 yrs), S/O-Md. Siraj 3) Imtiaz Alam (22 Yrs) S/O Ajim Klean all are of Vill-Sitarampur Tal Para, PS-Kulti. Dist-Paschim Burdwan 4) Md. Riyaz (22 Yrs) Lt. Md. Siraj of Asansol Pail Par, PS-Asansol (N), Dist-Paschim Burdwan along with seized articles such as 1. One from Bhojali having wooden but having length of approx 12.00 inch 2. One Iron rod which is one side arrow headed having length of approx 3½, ft. 3. One Damboo Stick having length of approx 4 feet as per seizure list.

I SI Dipak Kumer Pandey do hereby submit that on 01.11.2022 at 20:35 hrs while performing evening mobile duty vide C.C. No-3222/22, Dated-01.11.2022, received a source information that 06-08 persons were assembled beside Adra-Raghunathpur pitch Road near the "Swargadwar Pond edge" with a view to commit Decoity. I informed the matter to I/C Adra PS and as per order of I/C Adra PS, I along with forces namely 1) C/1455 Sudhangshu Kuiry 2) C/571 Hashib Khan 3) HG/1898 Anil Hembrom both of Adra PS left for Swargadwar Pond to work out the said information.

I along with force reached at "Swargadwar Pond at about 21:05 hrs by keeping the police vehicle at a distance of 300 meters (approx) away. Then we approached to the "Swargadwar Pond edge". We heard suspicious human voices at a distance from 25-30 meters, talking amongst themselves. I also found 06-03 persons were assembled there and after having heard and seen this, I along with forces confronted suspicious character as police party and they tried to flee away from the spot, but we able to apprehend above noted 04 persons. On being asked they disclosed their identity as noted above. Rest 03-04 persons fled away from the spot due to the darkness as well as the topography of the locality. Then I offered the detained persons to search me and my Police party before searching their body, but they refused. After that we searched them. During search I found 1. One Iron Bhojali having wooden butt having length of approx 12.00 inch recovered from the possession of Md. Aslam. 2. One Iron rod which is one side arrow headed having length of approx 31/2.ft recovered from the possession of Md. Miraj, 3. One Bamboo Stick having length of approx 4 feet recovered from the possession of Imtiaz Alam. On interrogation the accused persons disclosed their names and address as noted above and confessed that they were assembled there for committing Dacoity at Bankradanga village during this night. So, I seized the above noted articles and labeled duly signed by the police witnesses as no local witnesses available there then arrested them informing the ground of arrest, observing all arresting guidelines. As it was evident during our raid the accused persons assembled at a solitary place and were preparing amongst themselves with weapons found in their possessions for committing Dacoity at Bankradanga village, actually committed an offence punishable U/S- 399/402 IPC. In view of this I arrested the above noted 04 (Four) accused persons and seized the weapons from their possession by preparing proper seizure list on the spot duly signed by the accused persons as well as police party and brought them to P.S. The whole process was done i.e. search, seizure, and arrest in between 21.10 hrs to 22.05 hrs.

Hence I pray a specific case may kindly be started against 1) Md. Aslam (25 Yrs), S/O-Lt. Md. Jalil 2) Md. Miraj (35 yrs), S/O-Md. Siraj 3) Imtiaz Alam (22 Yrs) S/O Ajim Khan all are of Vill-Sitarampur Tal Para, PS-Kulti, Dist-Paschim Burdwan 4) Md. Riyaz (22 Yrs) Lt. Md. Siraj of Asansol Rail Par, PS-Asansol (N), Dist-Paschim Burdwan & other 03/04 unknown miscreants under proper section of law and arrange its investigation.
