In producing herewith the 07 (seven) arrested accused persons namely (1) Dibakar Sinha (27 Yrs) S/O Lt. Monoj Sinha of DVC Adra Kantaranguni, (2) Tinku Bauri (38 Yrs) S/O Lt. Fatik Bauri of DVC Adra Batt Tola near Eye Hospital, (3) Sanamaz Ansari (29 Yrs) S/O Khalil Ansari of Kantaranguni (4) Islam Ansary (38 Yrs) S/O Iyakub Ansari of Kantaranguni Banshkuli, (5) Manik Mandal (58 Yrs) S/O Lt. Balai Mandal of Beko village near Panchayat office, (6) Ranjit Bauri (38 Yrs) S/O Lt. Anadi Bauri of Beko Suri Kuli (Das Para), (7) Bibek Daw (25 Yrs) S/O Mukul Das of Kantaranguni DVC all are PS-Adra, Dist-Purulia and (8) Owner of the room and brought under seizure (i) 01 (One) Zebronics ADORE Black Color CPU, (ii) 01 (One) black colour Zebronics Monitor, SL No-RAA09UR7630 (iii) 01 (One) Citizen Black Color Printer, SL No-1452149 (iv) 01(One) Black color HP Mouse (v) One black colour Zelstar Monitor, SL No-RAA01KR00713 (vi) One black colour Intex CPU (vii) one black colour ROHS Pripter, SL No-HTPR No-58210810348 (viii) One Black colour HP Mouse (ix) Cash of Rs 830/- (Eight hundred thirty rupees only) under proper seizure duly signed by the witnesses as well as accused persons. I SI Dipak Kumar Pandey of Adra PS do hereby lodged complaint against above noted arrested accused persons to the effect that today (02.11.2022) at 22:05 hrs during night mobile duty vide Adra PS CC No-3233/22 dated 02.11.2022 received information from my reliable source that an online illegal gambling in the form of LOTO Lottery is going in a room situated at DVC More Sushanta Kr. Sinha, C/1290 Kuntal Nandi and accompanying with SDPO Raghu Nathpur sir reserve force left for DVC More to work out the information.

At about 22:25 hrs we reached at DVC More and as indicated by my source we entered into the mom and found that the above noted accused persons are operating online LOTO Lottery to some persons present there in lieu of money. Seeing the police persons the customers, those who were present there left that room and fled away however we could managed to detain of said accused persons. On search Cash of Rs 635/- (Six hundred thirty five rupees only) was found on the table in front of said accused persons. On being asked said detained persons disclosed their identities as noted above. On search apart from the cash the above noted articles ( SL No-i to SL No. ix) found present in that room in working condition and being used for the purpose of running such lottery. On demand they failed to produce any license or documents entrusted to them by any Govt. authority for running such online LOTO Lottery. On prolonged interrogation they admitted their guilt that they are running such online legal gambling in the form of LOTO Lottery to the common people in lieu of money for the wrongful gain and wrongful loss, also causing huge loss of Govt. revenue. The money Rs 830/- (Eight hundred thirty rupees only) of their table is the safe proceed of said online LOTO lottery for today up till now. So I seized the above articles including cash from the possession of the said detained accused persons duly signed by the accompanying Police forces. As the above noted accused persons committed an offence which is punishable u/s - 3/4 of WBG & PC Act. I arrested them after observing all formalities of arrest. The Search, seizure and arrest completed in between 22:45 hrs to 23:40 hrs.

Under the above fact and circumstances I pray that a case under section 3/4 of WBG & PC Act may kindly started against accused (1) Dibakar Sinha (27 Yrs) S/O Lt. Monoj Sinha of DVC Adra Kantaranguni, (2) Tinku Bauri (38 Yrs) S/O Lt. Fatik Bauri of DVC Adra Batt Tola near Eye Hospital, (3) Sanamaz Ansari (29 Yrs) S/O Khalil Ansari of Kantaranguni (4) Islam Ansary (38 Yrs) S/O Iyakub Ansari of Kantaranguni Banshkuli, (5) Manik Mandal (58 Yrs) S/O Lt. Balai Mandal of Beko village near Panchayat office, (6) Ranjit Bauri (38 Yrs) S/O Lt. Anadi Bauri of Beko Suri Kuli (Das Para) (7) Bibek Daw (25 Yrs) S/O Mukul Das of Kantaranguni DVC all are PS-Adra, Dist-Purulia and (8) Owner of the room u/s - 3/4 of W.B.G & PC Act and arrange for its investigation.
