Sir,

In producing herewith seized articles i.e. approx 2 (Two) ton of coal along with proper seizure list and all connected papers.

I beg to report that today (21.11.22) I SI Madan Chandra Supakar along with C/1455 Sudhangsu Kuiry and C/568 Madhusudan Rajowar performing R/T mobile duty vide Adra PS GDE No-887 dtd.21.11.22 and C.C. No-3910 dtd.21.11.22 at Adra PS area at about 12.30 hrs received an information that someone has staged huge amount of illegal coal at Gosaidanga field to sale it out side. On receiving such information I informed the matter to I/C Adra PS and as per his order I along with my accompanied force reached at Gosaindanga field. After identification of this actual plot by my source I reached at vacant place in the northern side of Gosaidanga field located near FCI Godown, Gosaidanga and found that a huge amount of coal has been staged at that place and 3/4 persons were present. On seeing the police party they fled away from this plot towards railway line. We tried to apprehend them, but failed. After that I waited at that place for considerable time but none come forwarded to demand the coal of his own. I also asked several local people but none could not say anything regarding the ownership of said coal. So there is sufficient reason to believe that the coal was taken and staged there by the way of stealing from some place in clandestine manner. So I seized approx 03 (Three) ton coal under proper seizure list duly singed by the police party as no one was agreed to sign in the seizure list.

Hence I pray that a specific case may kindly be started against owner of the land and other absconded accused persons.
