In producing here with one arrested accused namely Bidyut Dey @ Joy (39 yrs) S/O Lt. Dulal Dey of SBI Para Adra, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

- (1) 06 (Six) bottles of CAPTAIN country spirit, 600 Ml. each Rs-120/- of each bottle
- (2) 04 (Four) bottles DIL KHUSH country spirit, 600 Ml. each Rs-55/- of each bottle
- (3) 12 (Twelve) bottles OFFICER CHOISE deluxe whisky, 180 Ml. each Rs-130/- of each bottle
- (4) 03 bottle IMPERIAL BLUE classic grain whisky 180 Ml. each Rs-160/- of each bottle
- (5) 03 Bottles of MC Dowell's Rum containing 180 MI. each of Rs- 140/- each.
- (6) 02 Bottle of HAYWARBS 5000 beer containing 650 Ml. each of Rs- 120/- each

I SI Satrughna Mahato of Adra PS do here by lodged a complaint against accused namely Bidyut Dey @ Joy S/O Lt. Dulal Dey of SBI Para Adra, PS-Adra, Dist-Purulia to the effect that today i.e. 25/11/2022 in course of evening mobile duty as per order vide Adra PS CC No-3959/22 dtd.25.11.22. I received information from a reliable source at about 17:25 hrs that one Bidyut Dey @ Joy is selling country spirit illegally and foreign liquor in a room beside the Punjab Hotel of Adra Sabji Market. After getting such information I informed to I/C Adra P.S. over phone and as per his direction I along with accompanied force reached in a room beside the Punjab Hotel at Adra Sabji Market at about 17:55 hrs and held raid at that place and found that the above noted accd. Person selling country spirit and foreign liquor at said room near Adra Sabji Market and after seeing the Police party, all the person fled away and said Bidyut Dey @ Joy has tried to conceal himself but we able to apprehend him. I asked him to produced valid License or valid papers in respect of selling of country spirit and foreign liquor but he failed to produce any valid license or documents in respect possessing /selling the same. So it is sufficient reason to believe that above said Bidyut Dey @ Joy engaged to sale the country spirit and foreign liquor by illegal way. So I seized the above mentioned country spirit and foreign liquor under proper seizure list duly sign by accused person and available witnesses. I also collected sample from seized country spirit duly sealed and labeled by me. There after I arrest the above mentioned accused person informing him the ground of arrest. The complete process was done in between 17.25 hrs to 18.45 hrs.

I therefore pray that a specific case may kindly be start against arrested accused Bidyut Dey @ Joy (39 yrs) S/O Lt. Dulal Dey of SBI Para Adra, PS-Adra, Dist-Purulia under proper section of law.
