In producing here with one arrested accused namely Bhutnath Bauri (33 yrs) S/O Gopal Bauri of Vill-Kalikend, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

- (1) 12 (Twelve) bottle of HAYWARBS beer 650 Ml. each of Rs- 120/- of each bottle
- (2) 04 (Four) bottles OFFICER CHOISE of 180 Ml. each Rs-130/- of each bottle
- (3) 04 (Four) bottles ROYAL STAG, 180 Ml each bottle Rs-200/- of each bottle
- (4) 03 (Three) bottle IMPERIAL BLUE 180 Ml. each bottle Rs-160/- of each bottle
- (5) 04 (Four) bottles of MC Dowell's No-1, 180 Ml. each bottles Rs- 160/- each bottles.
- (6) 01 (One) bottles OFFICER CHOISE Blue, 500 Ml. Rs-400/-
- (7) 02 (Two) bottles ROYAL STAG, 375 Ml. each bottles Rs-370/- of each bottles
- (8) 03 (Three) bottle IMPERIAL BLUE 375 Ml. each bottles Rs-300/- of each bottle
- (9) 01 (One) bottle IMPERIAL BLUE of 750 Ml. Rs-590/-
- (10) 01 (One) bottle of MC Dowell's No-1, 350 Ml. Rs- 280/-

I SI Satrughna Mahato of Adra PS do here by lodged a complaint against accused namely Bhutnath Bauri (33 yrs) S/O Gopal Bauri of Vill-Kalikend, PS-Adra, Dist-Purulia to the effect that today i.e. 25/11/2022 in course of evening mobile duty as per order vide Adra PS CC No-3959/22 dtd.25.11.22. I received information from a reliable source at about 19:25 hrs that one Bhutnath Bauri is selling country spirit illegally and foreign liquor in a Jhopri at Mama More. After getting such information I informed to I/C Adra P.S. over phone and as per his direction I along with accompanied force reached in a Jhopri at Mama More at about 19:45 hrs and held raid in a Jhopri at Mama More and found that the above noted accd. Person selling country spirit and foreign liquor in a Jhopri at Mama More and after seeing the Police party, all the person fled away and said Bhutnath Bauri has tried to conceal himself but we able to apprehend him. I asked him to produced valid License or valid papers in respect of selling of country spirit and foreign liquor but he failed to produce any valid license or documents in respect possessing /selling the same. So it is sufficient reason to believe that above said Bhutnath Bauri engaged to sale the country spirit and foreign liquor by illegal way. So I seized the above mentioned country spirit and foreign liquor under proper seizure list duly sign by accused person and available witnesses. I also collected sample from seized country spirit duly sealed and labeled by me. There after I arrest the above mentioned accused person informing him the ground of arrest. The complete process was done in between 19.25 hrs to 20.25 hrs.

I therefore pray that a specific case may kindly be start against arrested accused Bhutnath Bauri (33 yrs) S/O Gopal Bauri of Vill-Kalikend, PS-Adra, Dist-Purulia under proper section of law.
