Sub: To lodge FIR against 1. owner of tractor and 2. driver of tractor namely Bhagirath Gorain (27 yrs) S/O Nagar Gorain of vill- Bhul, PS- Purulia(M), Dist- Purulia of one blue colour Swaraj 735 XM tractor without number plate, having Engine No. 391354SSH09527A, Chassis No. WRTH35625091689, along with trolley loaded with sand (approx 60 CFT).

Sir,

In producing herewith, one blue colour Swaraj 735 XM tractor without number plate, having Engine No. 391354SSH09527A, Chassis No. WRTH35625091689 along with trolley loaded with sand (approx 60 CFT). Today on 19.11.2022 at about 16.35 hrs acting on source information, I SI Uttam Kr. Mandal of Arsha PS along with (i) C/109 Surjatapa Dolai and (ii) C/146 Maheswar Singh Sardar both of Arsha PS, Dist-Purulia, left for PS area vide Spl. C.C No. 266 Dtd. 19.11.2022. After we reached at Beltola Ghat under Arsha PS at 17.15 hrs, we conducted raid on the Bank of River Kansai under Arsha PS and found that 01 (one) tractor along with trolley loaded with sand was present at Beltola Ghat on the Bank of River Kansai. Seeing the Police party the driver namely Bhagirath Gorain (27 yrs) S/O Nagar Gorain of vill- Bhul, PS- Purulia (M), Dist- Purulia of said tractor tried to flee away, but we apprehended him. I asked him to produce valid documents in support of carrying sand, but he could not produce as such documents. Hence I seized the above noted tractor along with trolley loaded with sand (approx 60 cft) and arrested the driver Bhagirath Gorain (27 yrs) S/O Nagar Gorain of vill- Bhul, PS- Purulia (M), Dist-Purulia after issuing memo of arrest and brought the said tractor and the driver to Arsha P.S. As there is every reason to believe that the driver and owner of the said tractor with ill motive were lifting and transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order as they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the 1. owner of tractor and 2. driver of tractor namely Bhagirath Gorain (27 yrs) S/O Nagar Gorain of vill- Bhul, PS- Purulia(M), Dist- Purulia of above noted tractor along with the trolley for investigation.
