In producing herewith, one green colour Jhon Deer tractor bearing Reg. WB55B/5021, having Engine No. PY3029D621812, Chassis No. IVY5105DKMA026341, along with trolley loaded with sand (approx 60 CFT). Today on 26.11.2022 at about 14.15 hrs during mobile duty acting on source information, I SI Anirban Dutta of Arsha PS along with (i) C/1516 Arnab Sinha and (ii) C/853 Kiran Ch. Murmu both of Arsha PS, Dist-Purulia vide Spl. C.C No. 268 Dtd. 26.11.2022, we reached at Gouradag Ghat under Arsha PS at 14.45 hrs and we conducted raid at Gouradag Ghat on the Bank of River Kansai under Arsha PS and found that 01 (one) tractor along with trolley loaded with sand was present at Gouradag Ghat on the Bank of River Kansai. Seeing the Police party the driver namely Maheswar Mahato (29 yrs) S/O Lt. Gobinda Mahato of vill- Ghagharjuri, PS- Purulia (M), Dist- Purulia of said tractor tried to flee away, but we apprehended him. I asked him to produce valid documents in support of carrying sand, but he could not produce as such documents. Hence I seized the above noted tractor along with trolley loaded with sand (approx 60 cft) and arrested the driver Maheswar Mahato (29 yrs) S/O Lt. Gobinda Mahato of vill- Ghagharjuri, PS- Purulia (M), Dist- Purulia after issuing memo of arrest and brought the said tractor and the driver to Arsha P.S. As there is every reason to believe that the driver and owner of the said tractor with ill motive were lifting and transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order as they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the 1. owner of tractor and 2. driver of tractor namely Maheswar Mahato (29 yrs) S/O Lt. Gobinda Mahato of vill- Ghagharjuri, PS- Purulia (M), Dist-Purulia of above noted tractor along with the trolley for investigation.
