Sub: Complaint against Rabi Lochan Mahato (38 Yrs), S/O- Buk Chand Mahato of Vill- Jagda, PS -Boro, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

## Respected Sir,

In Producing herewith arrested accd person Rabi Lochan Mahato (38 Yrs), S/O- Buk Chand Mahato of Vill- Jagda, PS - Boro, Dist - Purulia along with seized 21 (Twenty one) sealed bottles are containing 600 ml country spirit in each bottle styled as "DIL KHUSH" and 01 (one) bottle seized as sample from there as sell proceed from the possession of above noted accused which were seized under proper seizure list.

I beg to report that on 12.11.2022, at 18.05 hrs in course of Spl. Mobile Duty I PSI Malay Mishra of Boro PS received an information from my source over telephone that above noted person illegally stocked and selling "DIL KHUSH" to local public in his respective house. Accordingly I PSI Malay Mishra informed to O/C Boro PS in this regard. As per direction of O/C Boro PS, I PSI Malay Mishra along with force rushed to village Jagda at the above noted said house to work out the information. At about 18.45 hrs myself along with force reached the spot and hold raid at the above noted house and found that above noted person illegally stocked and selling "DIL KHUSH" to local public. On seeing police party the assembled local persons manage to flee away from the spot. On interrogation he disclosed his name and address as noted above. On demand he failed to produce any valid documents / License in respect of said illicit spirit which was kept in his house. Accordingly I seized 21 (Twenty one) sealed bottles are containing 600 ml country spirit in each bottle styled as "DIL KHUSH" and 01 (one) bottle seized as sample from there as sell proceed under proper seizure list in presence of witnesses, which is enclosed herewith. As such he was arrested at 19.35 hrs u/s 46 A (C) B.E. Act. 1909 and during arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to the arrestee. Out of seized "DIL KHUSH" country spirit 600 ml taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd. Rabi Lochan Mahato (38 Yrs), S/O- Buk Chand Mahato of Vill- Jagda, PS - Boro, Dist - Purulia violate section 18(i) B.E. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention and he committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) C/ 1246 Shaktipada Mahato, (2) C/ 851 Amrit Banerjee accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Rabi Lochan Mahato (38 Yrs), S/O- Buk Chand Mahato of Vill- Jagda, PS - Boro, Dist - Purulia.
