Sir,

In producing herewith the one accused person namely Buddheswar Sing Mura (37 Yrs), S/O- Lt. Dolgobinda Sing Mura of Vill- Simali, PS- Baghmundi, Dist- Purulia along with seized articles (1) 07 (Seven) liter ID Liquor containing in a white plastic jerican (2) 10 (Ten) Pcs Plastic Glasses, (3) 500 ml I.D liquor from Sl No. 1 as sample which were seized under proper seizure list duly signed by the witnesses.

I beg to submit that today on 28.11.2022 during my special mobile duty as per Suisa OP C.C No-1238/2022 & Suisa OP GDE No- 725, Dtd: 28.11.2022 received source information. Accordingly, I SI Subrata Sarkar along with force 1. C/1445 Bholanath Mistry, 2. NVF/811 Banbihari Mahato both of Suisa OP under Baghmundi P.S, Dist-Purulia reached at Simali village at about 18:45 hrs and found that the above noted person is selling I.D liquor in his tea stall. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. In between 18:55 hrs to 19:05 hrs I seized (1) 07 (Seven) liter ID Liquor containing in a white plastic jerican (2) 10 (Ten) Pcs Plastic Glasses, (3) 500 ml I.D liquor from Sl No. 1 as sample from his possession U/S- 67 B.E Act which were seized under proper seizure list duly signed by the witnesses. All seized articles were labeled properly in presences of witnesses and accused person. Hence I arrested the above noted person at 19:05 hrs after maintaining all formalities and guidelines regarding arrest. I also issued check list. I offered him for medical treatment but he refused.

The above noted arrested accused person namely Buddheswar Sing Mura (37 Yrs), S/O- Lt. Dolgobinda Sing Mura of Vill- Simali, PS- Baghmundi, Dist- Purulia committed an offence U/S- 46 (A)(c) B.E Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific case may kindly be started against the said accused person under proper section of law and arrange its investigation.
