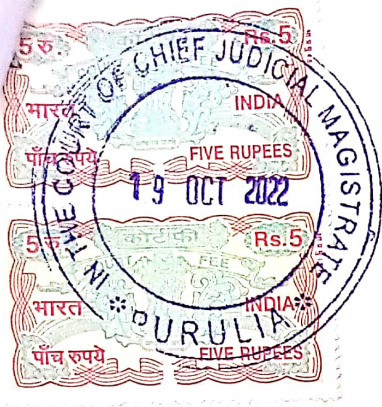

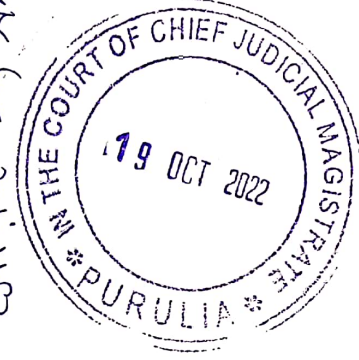

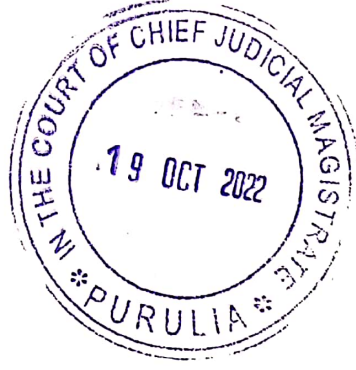

**Fact of the Case:**

- 1) That, the Complainant <sup>gave</sup> married his daughter <sup>to</sup> to Krishendu Singh Sardar of Village-Jaspurkumra under P.S. Bandwan on 18<sup>th</sup> Baisakh 1429 BS and after marriage daughter of Complainant went to her husband's house and lived as husband wife relation till 29.07.2022 on 01:00 PM, and on 29.07.2022 from the house of Krishendu Singh Sardar inform to the Complainant over telephone that daughter of Complainant was missing and advise to the Complainant to went to Bandwan Police Station and as per advice of in law's family of the Complainant, the Complainant and his wife lodged dairy before Bandwan P.S. being MP No.18 of 2022 dtd. 30.07.2022, GD No.1188/30/7/20 but till 30.07.2022 from two months the Police Concerned was silent and the Complainant come to learn from the reliable source, that the Accused No. 2 and his son i.e. Accused No. 1 kept the daughter of Complainant at village Panchukuda under P.S.
