Sir,

In producing here with arrested accused person namely Purna Kalindi (61 Yrs) S/o- Lt. Chaitan Kalindi of Vill- Manpur, P.O-Bamundiha, PS- Barabazar, Dist- Purulia and seized (i) One Plastic Jarakin containing approx 09 (Nine) Liters ID liquors (Cholai) (ii) 04 (Four) plastic Glasses and ½ Ltr taken as sample from mother container as per enclosed seizure list.

I, ASI Manas Kr. Pan of Barabazar PS do here by lodge this complaint against Purna Kalindi (61 Yrs) S/o- Lt. Chaitan Kalindi of Vill- Manpur, P.O-Bamundiha, PS- Barabazar, Dist-Purulia. I beg to state that today 10.11.2022 at about 17.35 hrs during my evening mobile duty I received telephonic information that one person was selling I.D liquor in his house at Manpur village. Accordingly I informed the matter to my I.C, and as per direction of I.C Barabazar PS at about 18.15 hrs myself along with C/- 664 Sahebram Soren & C/- 1211 Chunaram Hembram were arrived at Manpur village by Govt. vehicle to verify the credibility of that information. At about 18.35 hrs I detained one person in his house at Manpur village under Barabazar PS who was selling I.D liquors in his house. Seeing the Police party the alleged person and customers were tried to flee away, but somehow I apprehended the seller with the help of accompany force and on being searched I found One Plastic Jarakin containing approx 09 (Nine) Liters ID liquors (Cholai) and 04 (Four) plastic Glasses for selling of ID Liquor (Cholai) illegally. On demand, he failed to produce any valid documents / License in respect of stoking or selling of I.D liquors. On being asked he confessed his guilt and stated that he was stoking the ID liquors with intent to sell to make his own profit. He disclosed his identity as Purna Kalindi (61 Yrs) S/o- Lt. Chaitan Kalindi of Vill- Manpur, P.O-Bamundiha, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for selling of I.D liquors. Accordingly, I seized (i) One Plastic Jarakin containing approx 09 (Nine) Liters ID liquors (Cholai) (ii) 04 (Four) plastic Glasses after preparing proper seizure list and put label on the seized articles in presence of witnesses in which ½ Ltr. taken as sample which was also duly labeled by me and also took signature of the accompanying witness on seizure list and label as well as accused person also. The seizure and label was done in between 18.35 hrs and 18.55 hrs.

Thereafter, I secured arrest the accused person namely Purna Kalindi (61 Yrs) S/o- Lt. Chaitan Kalindi of Vill- Manpur, P.O-Bamundiha, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. I informed him regarding the ground of arrest and his relatives regarding arrest.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Purna Kalindi (61 Yrs) S/o- Lt. Chaitan Kalindi of Vill- Manpur, P.O-Bamundiha, PS- Barabazar, Dist- Purulia under proper section of Law.
