Sub: Complaint against Arup Kar Modak (48 Yrs) S/o- Lt. Lakshman Kar Modak of Vill- Barabazar Uparpara, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing herewith the arrested accused person namely Arup Kar Modak (48 Yrs) S/o- Lt. Lakshman Kar Modak of Vill- Barabazar Uparpara, PS- Barabazar, Dist- Purulia and seized one white colour plastic Jarican containing approx 09 (Nine) liters I.D liquors from which 500 ml taken as sample as per enclosed seizure list.

I, ASI Partha Sarathi Bose of Barabazar PS do here by lodge this complaint against Arup Kar Modak (48 Yrs) S/o- Lt. Lakshman Kar Modak of Vill- Barabazar Uparpara, PS- Barabazar, Dist- Purulia. I beg to state that on 20.11.2022 at about 18.45 hrs during my evening mobile duty I received telephonic information that one person was selling liquor in his house at Barabazar Uparpara. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with C/- 1474 Tushar Kanti Mandal & C/- 664 Sahebram Saren had been to the spot by Govt. vehicle to work out the information. At about 19.05 hrs I detained one person at Barabazar Uparpara under Barabazar G.P who was selling liquor in his house. Seeing the Police party the alleged person and customers tried to flee away, but I apprehended the seller with the help of the Police party and on being searched I found that the person was stocking approx 09 (Nine) liters I.D liquors for selling. On demand, he failed to produce any valid documents / License in respect of stocking or selling of I.D liquors. On being asked he confessed his guilt and stated that he was stocking the I.D liquors with intent to sell to make his own profit. He disclosed his identity as Arup Kar Modak (48 Yrs) S/o- Lt. Lakshman Kar Modak of Vill- Barabazar Uparpara, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for stocking & selling I.D liquors. Accordingly, I seized one white colour plastic Jarican containing approx 09 (Nine) liters I.D liquors after preparing proper seizure list and put label on the seized articles in presence of the witnesses from which 500 ml taken as sample which were also duly labeled by me and also took signature of the accompanying witness as well as accused person also on the Seizer list and label. The seizure and label was done in between 19.15 hrs and 19.45 hrs.

Thereafter, I secured arrest the accused person namely Arup Kar Modak (48 Yrs) S/o- Lt. Lakshman Kar Modak of Vill- Barabazar Uparpara, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. I informed him regarding the ground of arrest and also informed his relatives regarding arrest. The arrest was made on 22.11.2022 at 20.05 hrs.

After returning to PS, I prepared this complaint and submitted it before I.C Barabazar PS through Duty officer ASI Sadhan Ch. Danda to start a specific case against the arrested accused person namely Arup Kar Modak (48 Yrs) S/o- Lt. Lakshman Kar Modak of Vill- Barabazar Uparpara, PS- Barabazar, Dist- Purulia under proper section of Law.
