

The above name complainant begs to state as follows:

 That the complainant is the legally married wife of the accused no-1 Aditya Murmu and their marriage was





solemnized on 22/02/2007 as per our customary rights and the said marriage is still subsisting.

- 2) That at the time of marriage as per demand of the above noted accused persons and his inmates, father of the complainant had to pay a cash of Rs. 1,50,000/-, 7 bhories golden ornaments, 6 bhories silver ornaments, utensils, Palankh, Almirah, Dressing Table, etc., along with valuable articles to the above noted accused persons.
- house and started to reside with the accused person no-1 along with other inmates of the family in the same house and roof, initially the above noted accused persons behave with the complainant somehow well and good.
- 4) That at the time of marriage husband of the complainant was an unemployed person but he joined as Junior Constable, under Government of West Bengal in the year 2012. Since after joining in his service the accused no-1 changed himself and have gradually started misbehaved with the complainant duly instigated by other accused persons. The complainant

was not actually provided proper food and clothing and also assaulted her off and on causing physical as well as mental torture upon her.

- 5) That after marriage the complainant has passed in the examination of B.A.(Bachelor of Arts) and also got training of P.G.B.T. But during her education the accused no-1 did not provided the expenditure of her education.
- 6) That husband of the complainant never allowed the complainant to slip with the accused no-1 for which the complainant is still not blessed any children.
 - That bearing all such persistent torture the complainant somehow managed to continue at her matrimonial house, but ultimately persistent torture became unbearable for the complainant, for which the complainant was reported the matter to the village elderly i.e. the respectable persons on 11/02/2022 wherein the accused no-1 other inmates of the family admitted their guilty and they also promised to keep the complainant with proper care and prestige in their house and also promised that they will not inflict any such torture





upon the complainant and will provide proper food and clothing and one document was prepared to that effect, where the both the parties have put their respective signature upon the said document.

- 8) That the accused no-1 and his inmates could not keep their promise, but they again continuing various unbearable torture upon the complainant and ultimately the complainant was driven out from her matrimonial house on 15/10/2022 after good assault, and also threatened her that if she dare to come at her matrimonial hose in that case the accused persons will murder the complainant and disappeared my dead body.
- 9) That the accused no-1 contacted second marriage with one Deepali Hansda during the subsistence of the marriage with the complainant and keep her at the service place.
- 10) That the accused persons committed various offences punishable under the Indian penal code for which they are deserved to be punished under the law.
- 11) That the matter was reported to the Officer-in-charge Hura
