Sir,

In producing herewith arrested accused person namely Dilip Kumbhakar (30yrs) S/O- Pagdu Kumbhakar of Vill- Nekra, PS- Boro, Dist- Purulia, along with one seized vehicle bearing Registration No-JH05BQ/4493.

I beg to report that today myself along with C/1413 Kanailal Mondal, and C/ 1202 Swapan Roy both of Boro PS were performing Naka checking duty near Burudih more vide Boro PS C.C No-3270/22 dtd.22.11.2022 and GDE No-827 dtd- 22.11.2022. At about 20.25 hrs, I found one vehicle bearing Registration No-JH05BQ/4493 coming from Manbazar side rashly and negligently. We tried to stop him but the driver of the said vehicle named as above was trying to escape the place so rashly, there was every possibility of loss / serious injury of nearby public due to his such driving. Somehow we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On being asked he could not produce any valid license in respect of his driving. So, I arrested him as he violated Sec. 279 IPC and Sec. 181 of MV Act. I also seized the vehicle in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore I pray that a specific case may kindly be started against the accused Dilip Kumbhakar (30yrs) S/O- Pagdu Kumbhakar of Vill- Nekra, PS- Boro, Dist- Purulia.
