Sir,

In producing herewith one arrested accused Nityananda Mahato (53 yrs.) S/O- Lt. Chandrakanta Mahato of Vill- Rahamda, PS- Hura, Dist.- Purulia and one seized vehicle Tractor having registration no- WB 55A/7976 fitted with Trolley (without number plate) loaded with sand (approx 100 cft.). The fact of the case in brief is that I ASI Subhendu Mahato along with C/330 Banamali Soren, HG/1449 Mithun Majhi all of Hura PS were performing day mobile duty vide Hura PS CC No- 2661 Dtd- 21.11.2022 and GDE No- 1260 Dtd- 21.11.2022. During mobile duty on 21.11.2022 at about 07:35 hrs received credible source information that the above noted (Tractor) is coming from Pirolloya side loaded with sand. After receiving this information we were proceeding towards "Kalipur Jungle" under Hura PS. When we reached near "Kalipur Jungle" under Hura P.S at about 08:00 hrs we found that the above noted (Tractor) was coming from Pirolloya side towards Keshargarh. On seeing the Police party the driver of the said tractor tried to fled away but we managed to stopped and found that the tractor is loaded with sand. I asked the driver to produce valid documents in respect of Tractor as well loaded sand but failed to produce. As such there is every reason to believe that the driver and owner of the Tractor having registration No- WB 55A/7976 with an ill motive were transporting sand illegally without any valid document in support of carrying sand from Pirolloya ghaat. So they are liable for offence punishable U/S-379/411/414/120B IPC. Hence I seized the Tractor having registration No- WB 55A/7976 fitted with Trolley (without number plate) loaded with sand (approx 100 cft.) under proper seizure list in presence of Police witnesses duly signed by them in between 08:05 hrs. to 08:25 hrs. I also interrogated the driver regarding the ownership of the tractor but he has not disclose the identity of the owner finding no other alternative, I arrested driver of the Tractor namely Nityananda Mahato (53 yrs.) S/O- Lt. Chandrakanta Mahato of Vill- Rahamda, PS- Hura, Dist.- Purulia. During the time of arrest maintain all formalities regarding arrest and brought the said tractor as well as accused driver to Hura P.S.

Therefore, I am requesting you that a case against the driver namely Nityananda Mahato (53 yrs.) S/O- Lt. Chandrakanta Mahato of Vill- Rahamda, PS- Hura, Dist.- Purulia and owner of said Tractor having registration No. WB 55A/7976 fitted with Trolley (without number plate) to start a specific case and arrange for its investigation.
